## ORDER EXTENDING TIME

By Decision No. 79981 dated April 25, 1972, Union Ice & Storage Company was authorized to discontinue operations in 14,000 square feet of space in the Los Angeles Harbor District of the city of Los Angeles. Subsequent operations of the warehouse were to be conducted pursuant to Port Municipal Freezer Warehouse Tariff No. 1 of the Los Angeles Harbor District. It is alleged that representatives of the city of Los Angeles have advised applicant that the city no longer desires to have applicant operate said warehouse under the city's tariff. Applicant, therefore, requests authority to discontinue operations pursuant to Decision No. 79981 and to transfer the goods of 33 customers to the Shipside Warehouse of the Port of Los Angeles, which applicant's parent company operates as agent for. the city of Los Angeles. The Shipside Warehouse is located approximately a mile and a half away and applicant would bear the cost of such moving. Applicant anticipates no objection from its present storers.

The time for filing tariffs in compliance with Ordering Paragraph 3 of Decision No. 79981 expires on June 15, 1973.

Therefore, IT IS ORDERED that the time within which to comply with the provisions of Ordering Paragraph 3 of Decision No. 79981 is hereby extended to October 1, 1973 and the cost of transferring the property of applicant's customers to the Shipside Warehouse or to a warehouse of its customers' choice within the Los Angeles Area shall be borne by applicant.
