Decision No. 81519

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of BORDERLAND TRANSPORTATION COMPANY, INC., a corporation, dba GREAT WESTERN STAGE LINES, for a certificate) of public convenience and necessity to operate passenger service between San Fernando Valley and South Bay Companies.

Borderland Transportation Company, Inc., presently providing service as a charter-party carrier, requests a certificate of public convenience and necessity authorizing operations as a passenger stage corporation between points in the San Fernando Valley, on the one hand, and Aerospace Corporation located in El Segundo, Hughes Aircraft Company located in Culver City, Hughes Aircraft Company located in El Segundo, and TRW, Inc. located in Redondo Beach, on the other hand. Service would be intended for the transportation of employees of said companies.

Applicant owns and operates eight 41-passenger GMC buses and as of March 31, 1973 indicated a net worth in the amount of \$27,837.

Applicant proposes to operate daily schedules in conformity with the work shifts of each industrial plant to be served. Service would be provided over six routes for a daily round-trip fare of \$2.00 or for a weekly round-trip fare of \$9.25.

It is alleged that at the present time there is no direct public transportation between the proposed points; and that proposed service would provide a convenient alternative to the use of private automobiles for many of the employees of the companies to be served, thereby helping to reduce traffic congestion, noise, and air pollution.

Copies of the application were served upon various state, county, and city agencies, as well as upon public transportation carriers operating within the general area. No protest has been received.

After consideration the Commission finds that public convenience and necessity require the granting of the application. The Commission further finds, with reasonable certainty, that the project involved in this proceeding will not have a significant effect on the environment. A public hearing is not necessary.

Applicant is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

ORDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Borderland Transportation Company, Inc., a corporation, authorizing it to operate as a passenger stage corporation, as

defined in Section 226 of the Public Utilities Code, between the points and over the routes particularly set forth in Appendix A attached hereto and made a part hereof.

2. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations. Failure so to do may result in a cancellation of the operating authority granted by this decision.

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. Applicant is placed on notice that, if it accepts the certificate of public convenience and necessity herein granted, it will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series and insurance requirements of the Commission's General Order No. 101-Series.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.

(e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS

The certificate hereinafter noted supersedes all operative authority heretofore granted to Borderland Transportation Company, Inc., or its predecessors.

Borderland Transportation Company, Inc., by the certificate of public convenience and necessity, is authorized to transport passengers between points in Southern California and the Aerospace, Hughes, and TRW, Inc. plants in the South Bay Area and certain territories intermediate and adjacent thereto, over and along the routes hereinafter described, subject, however, to the authority of this Commission to change or modify said routes at any time and subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (b) When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- (c) All transportation of passengers shall involve a point on the route hereinafter described and the Aerospace, Hughes, and TRW, Inc. plants in the South Bay Area.
