ORDER OF SUSPENSION

Highway Carriers Association and California Trucking Association filed on June 15 and 20, 1973, respectively, petitions seeking suspension and reconsideration of Decision No. 81481 dated June 12, 1973, in the above proceedings, involving proposed decreases in the minimum rates due to repeal of the Motor Vehicle Transportation License Tax by the 1972 Legislature.

Under the terms of Section 1733 of the Public Utilities Code, the effective date of the order is stayed until the petitions are granted or denied. As information to interested parties affected, suspension supplements to Minimum Rate Tariffs 2, 3-A, 4-B, 6-A, 7, 8, 10, 11-A, 12, 14-A, 15, 17-A and 18 will be issued by the order herein.

IT IS ORDERED that:

Minimum Rate Tariffs 2, 3-A, 4-B, 6-A, 7, 8, 10, 11-A, 12, 14-A, 15, 17-A and 18 (Appendices D, A, C, A, A, C, A, A, A, A, D, C and B of Decisions Nos. 31606, 55537, 65521, 67154, 32566, 33977, 44633, 50114, 50218, 67397, 65072, 80578 and 72418, respectively, as amended) are further amended by incorporating:


