SUPPLEMENTAL OPINION AND ORDER

Glenn E. Walker, is a cement carrier operating by virtue of a certificate granted by Decision No. 69923, dated November 9, 1965, as amended by Decision No. 70058, dated December 7, 1965, in Application No. 46545.

By the Certificate of Amendment of the Articles of Incorporation duly filed with the Secretary of the State of California on February 13, 1973, Glenn E. Walker changed its corporate name to Pacific Western Industries, Inc. A petition for change of corporate name having been filed by Glenn E. Walker, its certificate will be amended to show the new corporate name. Because of the alter-ego conditioning shown on its operating authority and to reflect changes in corporate relationships that have occurred, a new appendix page will be issued. A public hearing is not necessary.

IT IS ORDERED that:

- 1. The certificate of public convenience and necessity issued by Decision No. 69923, in Application No. 46545, as amended, is further amended by substituting the name "PACIFIC WESTERN INDUSTRIES, INC." in the place and stead of "GLENN E. WALKER."
- 2. Appendix A of Decision No. 70058 is amended by incorporating First Revised Page 1, attached hereto, in revision of Original Page 1.

3. Within one hundred and twenty days after the date hereof, and on not less than five days' notice to the Commission and to the public, Pacific Western Industries, Inc., shall amend its tariffs on file with this Commission as required by Rule No. 6.2 of General Order No. 117.

This order is effective on the date hereof.

pacific Western Industries, Inc., by the certificate of public convenience and necessity granted in the decision noted in the margin is authorized to operate as a cement carrier as defined in Section 214.1 of the Public Utilities Code, to and within the Counties of Fresno, Imperial, Kern, Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara and Ventura from any and all points of origin.

Whenever Pacific Western Industries, Inc., engages other carriers for the transportation of property of Pacific Western Industries, Inc., and/or Mountain Rock Products, or customers or suppliers of said corporations, Pacific Western Industries, Inc., shall not pay such other carriers rates and charges less than the rates and charges published in Pacific Western Industries, Inc.'s tariffs on file with this Commission.

This certificate of public convenience and necessity shall lapse and terminate if not exercised for a period of one year.
