ORDER REVOKING WAREHOUSE OPERATIVE RIGHT

Donald B. Wyant, doing business as Allied Pacific Warehouse and Storage Co., possesses a certificate of public convenience and necessity as a public utility warehouseman for the operation of 15,000 square feet of storage or warehouse floor space in the County of San Joaquin in the vicinity of Stockton.

The 1970 annual report of Donald B. Wyant indicates that he received no revenue from public utility warehouse operations and did not dedicate any warehouse floor space to public utility storage at the aforementioned location. Annual reports for the calendar years 1971 and 1972 have not been filed with the Commission by the warehouseman as required by Section 584 of the Public Utilities Code.

Investigation of this matter by the Commission staff develops that this warehouseman is no longer operating the warehouse in question.

Donald B. Wyant requests by letter that the Commission revoke said operative right.

In the circumstances, the Commission finds that revocation of the warehouse operative right, as requested, would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the warehouse operative right should be

revoked and the tariff applicable to the services thereunder should be canceled.

IT IS ORDERED that:





1. The certificate of public convenience and necessity to operate as a public utility warehouseman granted to Donald B. Wyant by Decision No. 66103, dated October 1, 1963, in Application No. 45327, is hereby revoked.

2. Donald B. Wyant, doing business as Allied Pacific Warehouse and Storage Co., Warehouse Tariff No. 1, Cal.P.U.C. No. 1, is hereby canceled.

The Secretary is directed to cause service of a certified copy of this order to be made upon Donald B. Wyant or to mail a certified copy thereof to him at his last known address as shown in the Commission's records and to mail a copy of this order to Richard A. Bennett, Tariff Publisher, 319 E. Charter Way, Stockton, CA 95206.

The effective date of this order shall be twenty days after the date hereof.
