SUPPLEMENTAL OPINION AND ORDER

Lyon Van & Storage Co., a corporation, possesses certificates of public convenience and necessity and prescriptive operative rights to operate as a public utility warehouseman for the operation of storage or warehouse floor space at various cities in the State of California.

Lyon Van & Storage Co. has submitted to this Commission a copy of its Certificate of Amendment of Articles of Incorporation, certified by the Secretary of State, indicating that its corporate name has been changed to Lyon Moving & Storage Co. Accordingly, the certificates and operative rights will be amended to show the new corporate name. The warehouseman has amended its tariffs on file with the Commission pursuant to General Order No. 61-A. A public hearing is not necessary.

IT IS ORDERED that:

1. The certificates of public convenience and necessity granted to Lyon Van & Storage Co., a corporation, by Decisions Nos. 55574 and 77551 dated September 17, 1957, and July 28, 1970, in Applications Nos. 35076 and 52011, respectively, and the prescriptive operative rights as a public utility warehouseman possessed by Lyon Van & Storage Co., as determined by order dated September 1, 1960, in Case No. 6944, are amended by substituting therein "Lyon Moving & Storage Co." in place and stead of "Lyon Van & Storage Co."

2. Decision No. 55574 dated September 17, 1957, in Application No. 35076 is amended by incorporating therein Appendix A attached hereto and made a part hereof.





3. Appendix A of Decision No. 77551 is amended by incorporating therein Second Revised Page 1, attached hereto, in revision of First Revised Page 1.
