SUPPLEMENTAL OPINION AND ORDER

Dean Van Lines, Inc., a corporation, possesses a prescriptive operative right as a public utility warehouseman for the operation of storage or warehouse space at Dominguez in Los Angeles County.

Dean Van Lines, Inc., has submitted to this Commission a copy of its Certificate of Amendment of Articles of Incorporation, certified by the Secretary of State, indicating that its corporate name has been changed to Pan American Van Lines, Inc. Accordingly, its certificate will be amended to show the new corporate name. The warehouseman has amended its tariffs on file with the Commission pursuant to General Order No. 61-A. A public hearing is not necessary.

IT IS ORDERED that:

1. The prescriptive operative right as a public utility warehouseman possessed by Dean Van Lines, Inc., as determined by order of the Commission dated July 26, 1960, as amended by Decision No. 79165 in Case No. 6653, is further amended by substituting "Pan American Van Lines, Inc." in place and stead of "Dean Van Lines, Inc."




