ORDER VACATING AND
REMOVING SUSPENSIONS

On June 22, 1973, pursuant to Executive Order of the President of the United States announced on June 13, 1973, this Commission issued Decision No. 81514 suspending until further order of this Commission any rate increases authorized by the decisions listed in Appendix A, attached hereto and made a part hereof. On July 18, 1973, by Executive Order the President announced Phase IV economic controls which exempt therefrom, after August 12, 1973, all direct control over public utility rates; therefore,

IT IS ORDERED that the suspensions ordered by Decision No. 81514 as to rate increases authorized in the above-entitled proceedings and further described in Appendix A attached hereto are hereby vacated and removed. Any tariff filings necessary to implement the rate increases authorized by the decisions listed in Appendix A may be made after the effective date of this order. Rate increases resulting therefrom may become effective for service rendered on or after August 13, 1973.
