ORDER VACATING ORDER PARTIALLY SUSPENDING DECISIONS

In view of the Executive Order of the President of the United States, announced June 13, 1973, imposing a freeze on price increases for sixty days, rate increases authorized by the decisions listed in Appendix A attached hereto, and made a part hereof, in the above-entitled proceedings which could or would have become effective within such sixty-day period were suspended until further order of the Commission by Decision No. 81512.




Inasmuch as the aforementioned freeze on price increases will expire with August 12, 1973, the rates authorized by the decisions listed in said Appendix A and suspended by Decision No. 81512 should become effective not earlier than August 13, 1973. In the circumstances, Decision No. 81512 will be vacated and set aside.

IT IS ORDERED that:

1. Decision No. 81512 is hereby vacated and set aside effective August 13, 1973.
2. Tariff publications required or authorized to be made as a result of the order herein may be made effective not earlier than August 13, 1973, on one day's notice to the Commission and to the public.
3. The authority granted herein shall expire unless exercised within ninety days after the effective date of this order.

This order is effective on the date hereof.
