OPINION AND ORDER

By this application Haslett Company requests authority to cancel its participation from certain tariffs issued by Leland C. Smith, Agent, Pacific Motor Tariff Bureau, Inc. (PMTB) and, concurrently with the proposed cancellation, to enlarge its participation in certain tariffs issued by Western Motor Tariff Bureau, Inc. (WMTB). Applicant proposes not to publish for its

account in the WMTB tariffs certain rail competitive rates and commodity rates which it now maintains in the PMTB tariffs. 3

Applicant states it has determined that it would be in its best interest to consolidate its tariffs by cancelling its participation in the tariffs issued by PMTB and enlarging its participation in the tariffs issued by WMTB. Applicant asserts that it currently participates in the WMTB tariffs on joint service only and that all the inherent differences between these agency tariffs involve only local traffic.

Applicant alleges that the basic differences between these agency tariffs result principally in accessorial service rules and the establishment of like provisions for both local and joint service would be in the interest of tariff uniformity. Applicant declares that the rates it proposes, in effect, to cancel involved traffic which is no longer moving or which has been lost to competing highway carriers.

Applicant avers that increases resulting from the proposal herein would not increase its California intrastate gross revenue by as much as one percent.

Copies of the application were furnished to California Trucking Association, Leland C. Smith, Agent, and Western Motor Tariff Bureau, Inc., Agent, on or about March 27, 1973. The application was listed on the Commission's Daily Calendar of March 29, 1973. No objection to the granting of the application has been received.


The rates to be canceled apply on various commodities between various points in northern California. They are set forth in detail in Items 1500, 1510, 1520, 1533.1, 1538.5, 1573, 1605, 1671.08, 1701, 1703, 1708 and 1715 of PMTB Local Freight and Express Tariff No. 8-A, Cal.P.U.C. No. 1, and Items 2030, 2040, 2050 and 2060 of PMTB Local Freight Tariff No. 6-F, Cal.P.U.C. No. 5.
