SUPPLEMENTAL ORDER

Decision No. 81582, issued July 10, 1973, in this proceeding contains inadvertent errors in connection with the "crossing numbers" specified for the Abel Street Overhead and a relocated grade crossing. In addition, it did not contain the necessary authority for abandonment of an at-grade crossing as requested by the city in its application. The order which follows will make the necessary corrections.

IT IS ORDERED that Crossing No. DA-39.4-A is substituted for Crossing No. DA-40.3-A, and that Crossing No. 4G-9.9-A is substituted for Crossing No. 4G-10.8-A, shown in the first paragraph of the Findings and Conclusions on page 1 and again in Ordering Paragraph 1 on page 2 of Decision 81582.

IT IS FURTHER ORDERED that the third sentence of the first paragraph of the Findings and Conclusions on page 1 of Decision No. 31582 be changed to read: "The City of Milpitas should be authorized to relocate the grade crossing near Milepost 40 on the Southern Pacific Transportation Company's 'DA Line' to a new location approximately 120 feet north of its present location by closing North Main Street Crossing No. DA-40.0 and constructing a new crossing to be identified as Railroad Avenue Crossing No. DA-39.95." IT IS FURTHER ORDERED that the following changes be made in Ordering Paragraph 3 of Decision No. 81582:

The first paragraph on page 3 shall be changed to read:

"The City of Milpitas is authorized to relocate the crossing of Southern Pacific Transportation Company tracks at Main Street to a new location at Railroad Avenue substantially as shown by plans (Exhibit C) attached to the application to be identified as Crossing No. DA-39.95."

The first paragraph on page 4 shall have the words "Railroad Avenue Grade Crossing" substituted for the words "Main Street Crossing".

A second paragraph shall be added on page 4 stating "Upon completion of the Railroad Avenue Grade Crossing, the existing grade crossing of Main Street, Crossing No. DA-40.0, located approximately 120 feet south of the authorized grade crossing shall be abandoned and physically closed."

IT IS FURTHER ORDERED that an additional Ordering Paragraph 6 be inserted on page 4 of Decision No. 81582 to read as follows:

"6. Upon completion of the grade separation, the existing crossing at grade of Main Street and tracks of The Western Pacific Railroad Company, identified as Crossing No. 4G-10.1 and located approximately 1,000 feet south of the authorized grade separation, shall be abandoned and physically closed."
