ORDER OF REVOCATION

By Decision No. 76446 dated November 18, 1969, in Application No. 51396, Keith L. Grimm dba North Bay Charter Service was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between the United Airlines Maintenance Base located at the San Francisco International Airport and the City of Petaluma and intermediate points.

It is understood that in early 1970, Community Enterprises, Inc., of Santa Ana, California, undertook negotiations with Keith L. Grimm regarding this certificate. However, no request for authority to transfer such rights has been received by the Commission.

Since February 12, 1971, North Bay Charter Service has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-C.

In a letter dated June 19, 1973 Keith L. Grimm has ... requested revocation of the passenger stage rights granted by Decision No. 76446 because of his non-use of them since February 12, 1971.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed

certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision No. 76446 in Application No. 51396 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Keith L. Grimm dba North Bay Charter Service are canceled upon the effective date of this order.

The Secretary is directed to mail a certified copy of this order to Keith L. Grimm at P. O. Box 456, Petaluma, CA 94952, and to Community Enterprises, Inc., 1001 South Grand Avenue, Santa Ana, CA 92705, last known addresses as shown on the Commission's records.

The effective date of this order shall be the twentieth day after the above mailing to Keith L. Grimm and Community Enterprises, Inc. unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
