ORDER MODIFYING DECISION

It appears necessary to clarify the intent of paragraph C.l.b.(5) in Appendix B, page 2 of 3 and paragraph I.G.l.b.(5) in Appendix C, page 2 of 2 in Decision No. 81620 by distinguishing into two separate paragraphs the two conditions of "exceptional circumstances" and "when the utility elects to install the extension underground for its operating convenience". Additional minor changes have been made to Appendix B and C of Decision No. 81620 to clarify the intent by adding the words "do not" in paragraph I.G.l.b.(5) and by correcting typographical errors.

APPENDIX B

CHANGES IN RULES OF ELECTRIC UTILITIES

Rule 15 (PG&E and SCE) Rule 20 (SDG&E)

LINE EXTENSIONS

- C. Overhead Extensions to Serve Residential Subdivisions or Developments
 - 1. Conditions of Service

Modify the first sentence as follows:

Overhead extensions may be constructed when conditions in either a. or b. below are found to exist.

Modify a. (1) as follows:

(1) The lots within the residential subdivision or the development existed as legally subdivision or development, or

Modify b. (2) as follows:

Insert the word "such" for the word "so" and insert the word "could" for the word "can".

Modify b. (3) as follows:

(3) Local ordinances or deed restrictions ... on a parcel of less than 3 acres, or any portion of a parcel of less than 3 acres.

Modify b. (5) by deleting the last sentence.

Add a new paragraph b.(6) as follows:

(6) The utility does not elect to install the extension underground for its own operating convenience. Whenever the utility elects to install the extension underground for its operating convenience, the extra cost compared with overhead shall be borne by the utility.

CHANGES IN RULES OF TELEPHONE UTILITIES

Rule 15 (PT&T and Continental) Rule 32 (GT/C)

LINE EXTENSIONS

I. General--Contd.

Modify G.l.b. (5) by inserting the words "do not" in the first line between circumstances and exist. Also delete the last sentence.

- Add a new paragraph G.l.b. (6) as follows:
- (6) The utility does not elect to install the extension underground for its own operating convenience. Whenever the utility elects to install the extension underground for its operating convenience, the extra cost compared with overhead shall be borne by the utility.
