ORDER OF REVOCATION

By Decision 66955 dated March 17, 1964, in Application No. 45907, as amended by Decision 69886 dated November 2, 1965, in Application No. 47623, Paso Robles Chamber of Commerce was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation to transport passengers and their baggage between Paso Robles, on the one hand, and San Simeon, on the other hand.

In a letter dated August 27, 1973, Mr. F. W. Jewell, Manager of the Paso Robles Chamber of Commerce, informed the Commission that the organization is not providing service between Paso Robles and San Simeon and requested revocation of the Certificate of Public Convenience and Necessity.

Annual reports filed by the Paso Robles Chamber of Commerce indicate no income and no equipment since 1965.

Paso Robles Chamber of Commerce has no evidence on file with the Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-C.

It appears, and the Commission finds, that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the

certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Paso Robles and San Simeon authorized by Decision 66955 in Application No. 45907, as amended by Decision 69886 in Application No. 47623, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Paso Robles Chamber of Commerce are canceled upon the effective date of this order.

The Secretary is directed to mail a certified copy of this order to Paso Robles Chamber of Commerce, 1028 Spring Street, P.O. Box 457, Paso Robles, CA 93446, last known address as shown on the Commission's records.

The effective date of this order shall be the twentieth day after the above mailing to the Paso Robles Chamber of Commerce unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearings in which event the effective date of this order shall be stayed until further order of the Commission.
