## SUPPLEMENTAL ORDER

The order in Decision No. 79955 ordered various parties, including Leo Sparks, to collect undercharges from Northern Cement Transportation, Inc. (paragraph 2) and ordered Northern Cement Transportation, Inc. to pay undercharges to various parties, including Leo Sparks (paragraph 3). The order also required Leo Sparks to pay a fine of \$1,145.42, the amount of the undercharges, upon collection of said amount from Northern Cement Transportation, Inc. (paragraph 9).

By letter dated September 4, 1973, the attorney for Northern Cement Transportation, Inc. advised the Commission that the whereabouts of Leo Sparks is unknown and therefore cannot be paid the undercharges pursuant to Decision No. 79955.

Since the amount of the undercharges to be paid by Northern Cement Transportation, Inc. to Leo Sparks and the fine to be paid by Leo Sparks are identical amounts,

IT IS ORDERED that:

1. Northern Cement Transportation, Inc. shall pay the undercharges (\$1,145.42) to the Commission within ten days after the effective date of this order.
