ORDER VACATING SUSPENSION

Decision No. 82015, in this proceeding amended the findings of fact and conclusions of law in Decision No. 81656 and denied the petition of California Trucking Association for reconsideration, revision or rehearing of this matter in all other respects.

In the circumstances, the Commission finds that Decision No. 81751, which provided for suspension of the involved tariff pages, should be vacated. A public hearing is not necessary. The Commission concludes that Minimum Rate Tariff 15 should be amended accordingly.

2. Minimum Rate Tariff 15 (Appendix B of Decision No. 65072, as amended) is hereby further amended by incorporating therein Supplement 10 which supplement is attached hereto and by this reference made a part hereof.
