In the Matter of the Application of SOUTHWEST WATER COMPANY, a California corporation, for authority to increase its rates charged for water service in its La Mirada District of offset increased costs of water supplies purchased from SUBURBAN WATER SYSTEMS.

Application No. 54111 (Filed June 18, 1973)

<u>OPINION</u>

Southwest Water Company requests, for its La Mirada District, authority to increase its general metered service rates by 0.4 cents per 100 cubic feet over the rates requested in Application No. 53963 to offset increases in costs of purchased water supplied by Suburban Water Systems. The requested increase would add about 8 cents to the monthly bill of a typical commercial customer with a consumption of 2,000 cubic feet per month presently costing \$6.75.

Application No. 54096 filed by Suburban Water Systems requested certain offset relief. This application was granted by Decision No. 81655, effective July 31, 1973.

Applicant, a California corporation, furnishes general metered water service to approximately 10,000 customers located in ~ the city of La Mirada and vicinity, and in Los Angeles and Orange Counties. The rates for general metered service now in effect for the La Mirada District were established by Decision No. 80476 dated September 12, 1972 in Application No. 52640, as modified by Decision No. 81688 dated July 31, 1973 in Application No. 53963 (which granted offset relief regarding certain increases in costs of water supplies).

The Commission staff reviewed the information contained in this application as well as in work papers and has made an independent analysis. The results of the staff study are contained in a report dated July 11, 1973 and received herein as Exhibit 1. The staff has determined that applicant's computations supporting the requested increase are reasonable and concludes that while the increase will offset the effect of the increased expenses previously specified, it will not produce earnings resulting in a rate of return in excess of the previously authorized rate of return of 7.3 percent for this district.

The staff recommends granting of the application. Notice of the application was given in accordance with the Commission's rules. There are no protests. Findings

1. Since July 31, 1973, applicant has experienced certain increases in costs of purchased water supplied by Suburban Water Systems.

2. The amounts of these increases in expenses as set forth in the application and Exhibit 1 are reasonable.

3. The rate increase to be authorized will offset the effect of the increase in these expenses.

4. The rate of return produced as a result of the increases authorized will not exceed the 7.3 percent rate of return previously authorized for this district in Decision No. 80476 dated September 12, 1972.

5. The increases in rates and charges authorized herein are reasonable; and the present rates and charges, insofar as they differ from those prescribed herein, are for the future unjust and unreasonable.

A public hearing is not necessary.

The Commission concludes that the application should be granted.
