OPINION AND ORDER

By Decision No. 79920, dated April 11, 1972, in Application No. 52871, Buford L. Smith, an individual, doing business as Smith's Charter Bus Service, was granted an in lieu certificate of public convenience and necessity to operate as a passenger stage corporation.

On May 21, 1973 Smith's Charter Bus Service expressed to the Commission its desire to discontinue service between certain points and the United Air Lines Maintenance Base at San Francisco International Airport. The routes included in this request, as described in the certificate of public convenience and necessity, are Routes Nos. 1, 7 and 9 which originate in the City of Fremont and Route No. 10 which originates in the City of Santa Clara.

According to the applicant there has been a significant decrease in revenue and simultaneously an increase in operating costs. As a result the carrier is forced to request termination of service over these routes.

It is understood that after posting of appropriate notice on the buses, Smith's Charter Bus Service abandoned certain routes from Fremont to the United Air Lines Maintenance Base on June 1, 1973. On June 8, 1973, after public notice, the carrier abandoned the route from Santa Clara to the Base. Other "home-to-work", carriers serve the Base from both Fremont and the Santa Clara area.

The granting of this request would affect certain patronage of the carrier; however, it is noted that the services of other certificated carriers are available to those persons living in the areas near Smith's routes. A public hearing is not necessary.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation along Routes 1, 7, 9 and 10 authorized by Decision No. 79920 in

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation along Routes 1, 7, 9 and 10 authorized by Decision No. 79920 in Application No. 52871 is hereby revoked and the certificate of this carrier be restated as set forth in First Revised Pages 2, 4, 6 and 7 to Appendix A to Decision No. 79920 which is attached hereto. All effective tariffs and timetables which pertain to this service and are on file with the Commission in the name of Smith's Charter Bus Service shall be canceled upon the effective date of this order.

The effective date of this order shall be the 20th day after the above mailing to Mr. Buford L. Smith.
