ORDER TERMINATING INVESTIGATION

In Decision No. 77400 dated June 23, 1970, and Decision No. 78920 dated July 13, 1971 in Application No. 51294 and Case No. 9007 consolidated therewith, which authorized Southern California Edison Company to construct two additional electric generating units at its Huntington Beach Station subject to certain conditions, provision was made for continuing this investigation. The general purpose of the continued investigation was to assess plans for meeting electrical energy needs in the Southern California Edison service territory, together with plans for protecting the environment while so doing. After five days of public hearing during the period December 7, 1971 through April 25, 1972 the matter was taken off calendar and no further hearings were held.

The purpose of the continued investigation, however, is being carried out in part through the proceedings in pending Applications Nos. 53389, 53418, 53602, 53951, and 54148 filed

by Southern California Edison Company for authority to construct electric generation and transmission facilities and in part through Case No. 9581, the Commission's investigation into the adequacy and reliability of the energy and fuel requirements and supply of California electric public utilities. In the circumstances the Commission is of the opinion that the investigation under Case No. 9007 should be terminated.

Therefore, IT IS ORDERED that the investigation herein is terminated.
