**ORDER RESCINDING ORDER
IN DECISION NO. 81481
AND SUBSEQUENT ORDER
GRANTING REHEARING**

Decision No. 81481, issued June 12, 1973, in the captioned continuing minimum rate proceedings found that the various minimum rate tariffs embraced within the scope of the minimum rate proceedings should be adjusted to reflect a reduction in the rates contained therein predicated on the removal of the 1-1/2 percent Gross Receipts Tax as a result of the repeal of the Motor Vehicle Transportation License Tax Act (Revenue and Taxation Code, §§9601-10505, repealed July 1, 1973).

Decision No. 81547, issued June 26, 1973, suspended the tariff revisions ordered in Decision No. 81481 because timely filed petitions for rehearing of that decision by Highway Carriers

Association, California Trucking Association, and California Dump Truck Owners Association automatically stayed the order in Decision No. 81481 until the petitions were decided.

Decision No. 81826 dated September 5, 1973 granted the petitions for rehearing. The tariff provisions established in Decision No. 81481 remain under suspension.

Subsequent to the order granting rehearing, petitions in each of the captioned minimum rate proceedings have been filed which seek adjustment of minimum rates to reflect current cost conditions. In each such proceeding the effect of the repeal of the 1-1/2 percent Gross Receipts Tax has or will be given consideration in the tariff adjustments resulting from that proceeding.

In the circumstances the issues presented in Decisions Nos. 81481 and 81826 have become moot and those orders should be rescinded and the related tariff provisions should be cancelled.

IT IS ORDERED that:

1. The orders in Decision No. 81481 dated June 12, 1973 and Decision No. 81826 dated September 5, 1973 in the captioned proceedings are rescinded.

2. Minimum Rate Tariffs 2, 3-A, 4-B, 8, 10, 11-A, 12, 14-A, 15, 17-A, and 18 (Appendices D, A, C, C, A, A, A, A, D, C, and B of Decisions Nos. 31606, 55587, 65521, 33977, 44633, 50114, 50218, 67397, 65072, 80578, and 72418, respectively, as amended) are further amended by incorporating the following supplements to become effective March 29, 1974:

Supplement 111 in Minimum Rate Tariff 2;
Supplement 7 in Minimum Rate Tariff 3-A;
Supplement 25 in Minimum Rate Tariff 4-B;
Supplement 39 in Minimum Rate Tariff 8;
Supplement 21 in Minimum Rate Tariff 10
Supplement 14 in Minimum Rate Tariff 11-A;
Supplement 9 in Minimum Rate Tariff 12;
Supplement 7 in Minimum Rate Tariff 14-A;
Supplement 11 in Minimum Rate Tariff 15;
Supplement 7 in Minimum Rate Tariff 17-A; and
Supplement 8 in Minimum Rate Tariff 18.

These supplements are attached hereto and by this reference made a part hercof.

3. In all other respects, Decisions Nos. 31606, 55587, 65521, 33977, 44633, 50114, 50218, 67397, 65072, 80578, and 72418, as amended, shall remain in full force and effect.
