SUPPLEMENTAL INTERIM OPINION AND ORDER

By Decision No. 82726 entered today in Case No. 6008 (Petition 24) the Commission ordered a cost offset increase of approximately 7 percent in Minimum Rate Tariff 13 Territory A vacuum and pump tank truck rates and helper charge. This cost offset rate adjustment reflects fuel cost increases previously offset by a 3 percent interim surcharge supplement and order issued in this proceeding by Decision No. 82453 dated February 5, 1974. Application of the 3 percent interim surcharge supplement and order to charges resulting under the provisions of Minimum Rate Tariff 13 Territory A rates should, therefore, be canceled.

IT IS ORDERED that:

1. Application of the 3 percent interim surcharge supplement and order to charges determined under the provisions of Minimum Rate Tariff 13 Territory A rates is canceled effective April 27, 1974.

2. Minimum Rate Tariff 13 (Appendix A of Decision No. 44633, as amended) is further amended by incorporating therein, to become effective April 27, 1974, Supplement 1 attached hereto and by this reference made a part hereof.

3. In all other respects, Decision No. 44633, as amended, shall remain in full force and effect.

The effective date of this order is the date hereof.

APPLICATION OF SURCHARGE

Except as otherwise provided, compute the amount of charges under the Territory B rates and rules in this tariff and increase the amount so computed by three (3) percent, dropping fractions of less than one-half cent and increasing fractions of one-half cent or greater to one cent.

EXCEPTION:--The surcharge herein shall not apply on charges resulting under:

- (A) Item 60,
- (B) Paragraph 12 of Item 122,
- (C) The Territory "A" hourly rates in Item 200,
- (D) The deduction in the Note in Item 200,
- (E) Item 340,
- (F) Item 350 and
- (G) Item 360.
