ORDER RESCINDING ORDER GRANTING REHEARING,
DISMISSING PETITION FOR REHEARING AND RESCINDING,
IN PART THE OPINION AND ORDER CONSOLIDATING
CASE NO. 9269 INTO CASE NO. 9625

By Decision No. 81123, issued March 13, 1973, the Commission dismissed the complaint filed herein with prejudice. On April 2, 1973, A-Head Products, Inc., a corporation, (complainant) filed a petition for rehearing of Decision No. 81123 which stayed effective date of Decision No. 81123. The Commission granted rehearing in Decision No. 81371, issued May 15, 1973. The matter was set for hearing on October 16, 1973, but was temporarily removed from the calendar by order of the Commission dated October 12, 1973. By letter dated October 11, 1973, and received by the Commission October 15, 1973, counsel for the complainant informed the Commission that:

"Pursuant to our agreement with Mr. Michalski,
the General Attorney for Pacific Telephone and

Telegraph Company, we are dismissing our petition for re-hearing of the decision previously rendered by the Public Utilities Commission in Case No. 9269 with A-Head Products, Inc., Complainant, and The Pacific Telephone and Telegraph Company, a corporation, Defendant.

However, by Decision No. 82412, issued January 29, 1974, the matter was consolidated into the Commission's Case No. 9625 along with other complaint matters pending on the subject of interconnection.

In light of the above-cited letter of October 11, 1973, and the fact that the matters disputed in Case No. 9269 appear to have been resolved by the parties hereto,

IT IS ORDERED that:

1. Decision No. 81371, Order Granting Rehearing, is hereby rescinded.
2. The petition for rehearing of Decision No. 81123 filed by A-Head Products, Inc. is hereby dismissed.
3. Decision No. 82412, Interim Opinion and Order, is hereby rescinded insofar as it ordered consolidation of Case No. 9269 into Case No. 9625.
4. The effective date of Decision No. 81123 is the date hereof.
5. The effective date of this order is the date hereof.
