ORDER OF REVOCATION

By Decision No. 78899 dated July 13, 1971, in Application No. 52628, Richard Twining, doing business as Adams Charter Coaches, was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Napa and Mare Island Naval Shipyard, and intermediate points.

By Decision No. 30986, dated January 23, 1973, in Application No. 53720, (filed November 29, 1972) Richard Twining, doing business as Adams Charter Coaches and Scenic Highway Tours, Inc., was granted authority to sell and transfer the foregoing Certificate of Public Convenience and Necessity to Howard B. Pettersen, doing business as Pettersen Bus Company. Ordering Paragraph 2 required Pettersen Bus Company to file in writing with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect the transfer. No filing in accordance with the order has been received by the Commission.

On or about January 17, 1973, Richard Twining, dba Adams Charter Coaches, abandoned and ceased operations of the foregoing common carrier service.

A. 52623 TLR Since December 1, 1972, Richard Twining, doa Adams Charter Coaches has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-C. Under the circumstances, the Commission makes the following findings and conclusions: The authority of Richard Twining, doing business as Adams Charter Coaches, granted by Decision No. 78899, should be revoked because of non-use. 2. The authority to sell and transfer by Richard Twining, dba Adams Charter Coaches and/or Scenic Highway Tours, Inc., and for Howard B. Pettersen, dba Pettersen Bus Company, to purchase and acquire the operative rights and property as authorized by Decision No. 80986 in Application No. 53720 has expired. 3. The Certificate of Public Convenience and Necessity previously issued to Howard B. Pettersen to operate as a passenger stage corporation and authorized by Decision No. 73770 in Application No. 49852 as amended by Decisions Nos. 75536 and 76089 remains in effect. IT IS ORDERED that: The Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Napa and Mare Island authorized by Decision No. 78399 in Application No. 52628 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Richard Twining, dba Adams Charter Coaches and/or Scenic Highway Tours, Inc., are cancelled upon the effective date of this order. - 2 -
