SUPPLEMENTAL OPINION AND ORDER

Decision No. \$2849 dated May 7, 1974, in the above proceedings established revised rates in Minimum Rate Tariff 4-B for the transportation of household goods and related articles by highway carriers and provided for the cancellation of the 3-percent surcharge insofar as it applied to the hourly rates named therein.

It has come to the Commission's attention that uncertainty exists concerning the rates which will be subject to the surcharge effective July 1, 1974.

In the circumstances, the Commission finds that the application of the aforementioned surcharge should be clarified. A public hearing is not necessary. The Commission concludes that Minimum Rate Tariff 4-B should be amended accordingly.

IT IS ORDERED that:

- 1. Minimum Rate Tariff 4-B (Appendix C of Decision No. 65521, as amended) is further amended by incorporating therein to become effective July 1, 1974, Supplement 28 attached hereto and made a part hereof.
- 2. Common carriers subject to the Public Utilities Act, to the extent that they are subject also to Decision No. 65521, as amended, are hereby directed to establish in their tariffs

C. 5330 (Pets. 79, 82 and 83) - LTC

the amendment necessary to conform with the further adjustments ordered herein.

- 3. Tariff publications required to be made by common carriers as a result of the order herein shall be filed not earlier than the effective date of this order and shall be made effective July 1, 1974, on not less than one day's notice to the Commission and to the public.
- 4. Common carriers, in establishing and maintaining the amendment authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the amendment published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.
- 5. In all other respects Decision No. 65521, as amended, shall remain in full force and effect.

The effective date of this order shall be June 28, 1974.
