ORDER OF REVOCATION

By Decision No. 76779 dated February 10, 1970, in Application No. 51574, Daniel N. Tanner and Gary L. Tanner, doing business as Tanners Trolley, were granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Nevada City and Grass Valley and intermediate points.

The carrier at its request was authorized by Decision No. 80900 to suspend its bus operation from December 2, 1972 until December 1, 1973 because of its inability to pay the cost of liability insurance.

On April 15, 1974, the Commission staff mailed a letter to the Tanners at 106 Walrath Avenue, Nevada City, CA 95959. The letter was forwarded by the Post Office to 437 - 12th Street, Reno, Nevada, before it was returned to the Commission.

The City Clerk of Grass Valley and the City Clerk of Nevada City informed this Commission on April 17, 1974, that Tanners Trolley was no longer conducting the bus operations.

as required by General Order No. 101-C.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables

applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Nevada City and Grass Valley authorized by Decision No. 76779 in Application No. 51574 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Tanners Trolley are canceled upon the effective date of this order.
