SUPPLEMENTAL ORDER

Loren B. Joplin, doing business as SUBURBAN COMMUTER SERVICE, seeks, by this petition for modification, authority to modify the route between Simi Valley and Zuma Beach granted by Decision No. 83098 dated July 2, 1974, in this application.

The applicant states that a segment of the proposed route in the Thousand Oaks area was inadvertently omitted from the original application, and that the route sought by this petition includes this segment which is necessary to serve the Newbury Park District.

The Commission finds that the route authorized by Decision No. 83098 should be so modified.

IT IS ORDERED that:

1. Original Page 4 of the Appendix A Certificate of Public Convenience and Necessity attached to Decision No. 83098 in this application is cancelled, and in its stead is adopted First Revised Page 4, attached hereto and by reference made a part hereof.

SECTION 2. ROUTE DESCRIPTIONS (Continued)

*Route 3 - Simi Valley/Zuma Beach Route

Commencing at the intersection of Menlo Street and Kuehner Drive, in the City of Simi Valley, thence via Kuehner Drive, Los Angeles Avenue, Sycamore Drive, Royal Avenue, Madera Road, Olson Road, and Moorpark Road to its intersection with Janss Road, thence via Janss Road, Lynn Road, Ventura Freeway, Ven Tu Park Road, Newberry Street, Theresa Drive, Borchard Road, and Reino Road to its intersection with Potrero Road, thence via the reverse of the above to the intersection of Moorpark Road and Janss Road, thence via Moorpark Road, Thousand Oaks Blvd., Westlake Blvd., Agoura Rd., Kanan Rd., Point Dume Rd., and the Pacific Coast Hwy. to Zuma State Beach.
