In the Matter of the Application of California Sightseeing Tours, Inc. To transfer and of Educational and Recreational to acquire a certificate of public convenience and necessity.

Application No. 54950 (Filed June 10, 1974)

OPINION

Applicants request the transfer of certificates of public convenience and necessity as a passenger stage corporation issued to California Sightseeing Tours, Inc., hereinafter California, a wholly owned subsidiary of Educational and Recreational Services, Inc., hereinafter Educational, to Educational.

The authority to be transferred was secured by California by Decision No. 76608 dated December 23, 1969 in Application No. 51537. That decision states that all the common stock of California is held by Educational. The routes of California were subsequently altered and/or extended by Decision No. 77922 dated November 10, 1970 in Application No. 52058; Decision No. 78285 dated February 9, 1971 in Application No. 51678; Decision No. 79272 dated October 27, 1971 in Application No. 52338; and Decision No. 82794 dated April 30, 1974 in Application No. 54649.

California and Educational have a consolidated operation (Exhibit "E" on the application) with current assets as of March 31, 1974 of \$4,566,187 and current liabilities of \$1,495,733. For the six months ended March 31, 1974 they had a net income of \$688,650 after provision for state and federal income taxes.

The Commission finds with reasonable certainty that the project involved will not have a significant effect on the environment.

A. 54950 - SW After consideration the Commission finds that the proposed transfer would not be adverse to the public interest and concludes that it should be authorized. A public hearing is not necessary. The order which follows will provide for, in the event the transfer is completed, the revocation of the certificates presently held by California Sightseeing Tours, Inc., and the issuance of a certificate in appendix form to Educational and Recreational Services, Inc. Educational and Recreational Services. Inc. is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given. ORDER IT IS ORDERED that: On or before December 1, 1974, California Sightseeing Tours, Inc. may sell and transfer the operative rights referred to in the application to Educational and Recreational Services, Inc. 2. Within thirty days after the transfer the purchaser shall file with the Commission written acceptance of the certificate and a true copy of the bill of sale or other instrument of transfer. -2A. 54950 1mm **

- 3. Purchaser shall amend or reiscue the tariffs and timetables on file with the Commission, naming rates and rules governing
 the common carrier operations transferred to show that it has
 adopted or established, as its own, the rates and rules. The
 tariff and timetable filings shall be made effective not earlier
 than ten days after the effective date of this order on not less
 than ten days' notice to the Commission and the public, and the
 effective date of the tariff and timetable filings shall be concurrent
 with the transfer. The tariff and timetable filings made pursuant
 to this order shall comply in all respects with the regulations
 governing the construction and filing of tariffs and timetables set
 forth in the Commission's General Orders Nos. 79-Series and 98-Series.
 Failure to comply with the provisions of General Orders Nos. 79-Series
 and 98-Series may result in a cancellation of the operating authority
 granted by this decision.
- 4. In the event the transfer authorized in paragraph 1 is completed, effective concurrently with the effective date of the tariff filings required by paragraph 3, a certificate of public convenience and necessity is granted to Educational and Recreational Services, Inc., a corporation, authorizing it to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes set forth in Appendix A, attached hereto and made a part hereof.
- 5. The certificate of public convenience and necessity granted by Decision No. 76608, as subsequently modified, is revoked effective concurrently with the effective date of the tariff filings required by paragraph 3.
- 6. Purchaser shall comply with the safety rules of the California Highway Patrol, the rules and regulations of the Commission's General Order No. 98-Series, and insurance requirements of the Commission's General Order No. 101-Series.

7. Purchaser shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

The effective date of this order shall be twenty days after the date hereof.

SECTION 1 - GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Educational and Recreational Services, Inc., by the Certificate of Public Jonvenience and Necessity granted by the decision noted in the margin, is authorized to:

- (1) Transport passengers for sightseeing purposes, commencing at the Los Angeles Harbor (San Pedro and Wilmington) to points of interest in Los Angeles and Orange Counties and returning to the point of beginning in the Los Angeles Harbor, over and along the routes hereinafter described in Section 2, subject to the following conditions and restrictions:
 - (a) Service shall be limited to the transportation of round-trip passengers, originating in the Los Angeles Harbor, San Pedro and Wilmington.
 - (b) Service shall be operated in conjunction with tour steamship arrivals and subject to a minimum of ten adult passengers.
- (2) Transport passengers and their baggage in service other than sightseeing, between Los Angeles International Airport, on the one hand, and Los Angeles Harbor (San Pedro and Wilmington), on the other hand, over and along the route described in Section 2, subject to the following conditions and restrictions:
 - (a) Service shall be limited to transportation of persons with prior or subsequent passage on steamships docking at Los Angeles Harbor.

- (b) San Pedro, Wilmington, Hermosa Beach, Redondo Beach, Torrance, Gardena-Compton, Canoga Park, El Monte, Inglewood and Los Angeles, on the one hand, and the Santa Anita Race Track, on the other hand.

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operations in either direction unless otherwise indicated.
- c. Authority is granted to operate motor coaches in excess of 35 feet, but not in excess of 40 feet, in length and in excess of 96 inches, but not exceeding 104 inches in width, between points and over all routes except between Los Angeles County points, on the one hand, and San Ysidro, on the other hand.
