BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of G & J FREIGHT, INC. for Amendment of its Certificate of Public Convenience and Necessity as a Highway Common Carrier to exclude the transportation of fertilizing compounds (manufactured fertilizer), liquid or dry, except shipments thereof which have a prior or subsequent movement by for-hire rail, motor, or water carrier.

G & J Freight, Inc. requests that its certificated authority as a highway common carrier, which has been registered with the Interstate Commerce Commission, be amended by restricting the transportation of fertilizing compounds (manufactured fertilizer), liquid or dry, to shipments thereof having a prior or subsequent movement by for-hire rail, motor, or water carrier.

The certificate was granted to one of applicant's predecessors by Decision No. 53166 in Application No. 35493 and authorizes the transportation of specified commodities, including fertilizing compounds (manufactured fertilizer), liquid or dry, between various points within the state.

It is alleged that applicant is performing substantial service in the transportation of fertilizers pursuant to the authority issued to it by the certificate above mentioned; that applicant has determined that said service to its shippers can better be performed pursuant to its permitted authority; that applicant holds a radial highway common carrier permit authorizing the transportation of general commodities with certain exceptions throughout that part of the State of California within a radius of 350 miles of Fresno, excluding operations wholly within the city and county of San Francisco; that

said permit embraces all of the points between which applicant renders service in the transportation of fertilizer under its certificate; that fertilizers move under special arrangement in large volumes in many cases, and require the fixing of charges for services based upon the singular nature of each operation; that many shipments are delivered to spreader trucks, farms, and others to wholesalers; that shipments of fertilizer are exempt from rate regulation in Minimum Rate Tariff 2, as shown in Item 40 thereof; that many permitted carriers compete with applicant and are not required to assess any particular rates, whereas applicant is bound by its published tariff; that applicant is therefore subject to diversion of freight from shippers by reason of rate cutting by its competitors; that the granting of the application will enable applicant to compete equally and fairly with such permitted carriers; that applicant and its shippers desire to be able to negotiate specific contractual terms which will provide appropriate provisions for the peculiar circumstances involved in many of the shipments; and that applicant wishes to maintain its highway common carrier authority to transport said commodities when they have a prior or subsequent movement by for-hire rail, motor, or water carrier, since in said circumstances through rates may be applicable.

After consideration the Commission finds that public convenience and necessity no longer require applicant's service as a highway common carrier in the transportation of fertilizing compounds (manufactured fertilizer), liquid or dry, except when shipments thereof have a prior or subsequent movement by for-hire rail, motor, or water carrier.

We further find with reasonable certainty that the project involved in this proceeding will not have a significant effect on the environment.

The Commission concludes that the application should be granted as provided by the order herein. A public hearing is not necessary.

The order which follows will provide for the revocation of the certificate presently held by applicant and the issuance of an in lieu certificate, which, except for the amendment herein provided for, will not broaden or change the rights that it presently holds.

Applicant is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

<u>O R D E R</u>


IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to G & J Freight, Inc., a corporation, authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points set forth in Appendix A, attached hereto and made a part hereof.

2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure so to do may result in cancellation of the authority.

> (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules of the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-Series.



- (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and amend or reissue tariffs, in triplicate, in the Commission's office.
- (c) The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the establishment of the authorized service.
- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-Series.
- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- (f) Applicant shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If applicant elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

3. The certificate of public convenience and necessity granted in paragraph 1 of this order shall supersede all of the certificates of public convenience and necessity acquired by applicant pursuant to Decision No. 66186, as amended, dated October 22, 1963 in Application No. 45639 and Decision No. 72591, as amended, dated June 9, 1967 in Application No. 49015, which certificates are

revoked effective concurrently with the effective date of the tariff filings required by paragraph 2(b).
