Cor-O-Van Corporation requests authority to discontinue operations as a public utility warehouseman at Coronado and Lemon Grove. The operations are authorized by a certificate of public convenience and necessity granted to applicant by Decision No. 76942 dated March 17, 1970 in Application No. 51698.

The application states as follows: For several years past, applicant has performed no public utility warehousing operations at Coronado because of lack of patronage and maintains no warehouse facilities at this location; it has a warehouse facility in Lemon Grove; the Lemon Grove facility is utilized almost exclusively for the storage of used household goods, which are exempt commodities, because of little or no demand for public utility storage service; in the event the sought cancellation is granted, applicant agrees to transfer, at its cost, any commercial storage lots that may be in its Lemon Grove warehouse to any public utility warehouse of the depositor's choice within the vicinity; there are other public utility warehouse facilities within close proximity of Coronado and Lemon Grove with available storage space; and thus the public will not be adversely affected by the sought cancellation of applicant's certificate.

The Commission finds that public convenience and necessity no longer require applicant's service as a public utility warehouseman at Coronado and Lemon Grove. A public hearing is not necessary. The Commission concludes that the application should be granted.

O R D E R

IT IS ORDERED that:

1. After the effective date hereof, Cor-O-Van Corporation may discontinue operations as a public utility warehouseman at Coronado and Lemon Grove, and the authority set forth in the certificate of public convenience and necessity granted to it by Decision No. 76942 dated March 17, 1970 in Application No. 51698 is revoked.

2. In the event there are any public utility storage patrons of applicant's Lemon Grove warehouse, applicant shall comply with the following conditions:

- a. Notify each of the patrons, within twenty days after the date hereof, of the authorization granted herein to discontinue operations as a public utility warehouseman at Lemon Grove.
- b. Each patron may designate any available public utility warehouse or other location within the vicinity of Lemon Grove to which his stored property shall be moved; however, in the absence of such election on or before thirty days after the date hereof, applicant may transfer such property to any public utility warehouse within that vicinity.
- c. Applicant shall pay, for its own account, and at no expense to its patrons, any and all costs connected with the transfer of stored property referred to in paragraph b.

3. Within one hundred twenty days after the date hereof and on not less than ten days' notice to the Commission and the public, applicant shall make appropriate tariff filings reflecting the authority herein granted.
