ORDER REVISING CERTIFICATE OF PUBLIC CONVENIENCE
AND NECESSITY

By Decision No. 81659 dated July 31, 1973, Golden West Airlines, Inc., was authorized to discontinue Palm Springs service pursuant to its petition of June 25, 1973. Golden West Airlines has discontinued Palm Springs service, complied with the Ordering Paragraphs of Decision No. 81659 regarding notice to the public and deleted reference to Palm Springs from its tariffs. Its current Certificate of Public Convenience and Necessity shows Palm Springs. The Commission finds good cause to delete reference to Palm Springs in Golden West's certificate.

By Decision No. 77323 dated June 9, 1970, the Commission authorized Golden West Airlines to serve El Monte pursuant to its application filed on June 1, 1969, for a "Grandfather" passenger air carrier certificate. It has come to the attention of the Commission that Golden West Airlines has not served El Monte Airport for approximately two years. Public timetables on file with the Commission do not show an offering of service at El Monte since July 1, 1972. The Commission finds that the discontinuance of service at El Monte is good cause for revocation of authority to serve this point.

In Decision No. 79244, dated October 13, 1971, the Commission authorized Golden West Airlines, Inc., to serve Tri-City Airport. It has come to the attention of the Commission that Golden West Airlines has not served Tri-City for approximately one year. Public timetalles on file with the Commission do not show an offering of service to Tri-City since June 1, 1973. The Commission finds that the discontinuance of service at Tri-City is good cause for revocation of authority to serve this point.

A. 51216 TLR By Decision No. 78538 dated April 13, 1971, the Commission authorized Golden West Airlines to serve Mojave, Kern County Airport No. 7. It has come to the attention of the Commission that an airport district has been formed for Mojave and that the correct name of the airport is Mojave Airport. The Commission finds that this correction should be made in Golden West Airlines' certificate. By Decision No. 77323, dated June 9, 1970, in Application No. 51216, Golden West was granted a "Grandfather" Certificate of Public Convenience and Necessity which required that no aircraft having more than 25 revenue passengers be operated. Decision No. 81416, dated May 22, 1973, in Applications Nos. 53623 and 53640, Swift Aire Lines' and Valley Airlines' certificates were revised from a 25 revenue passenger limitation to the operation of aircraft of not more than 30 passengers or a payload of not more than 7,500 pounds. The Commission finds that it is in the interest of an orderly, efficient, economical and healthy intrastate passenger air network that Golden West's certificate should be similarly revised. IT IS ORDERED that: 1. Golden West Airlines' Certificate of Public Convenience and Necessity shall be revised to delete reference to Palm Springs. 2. Authority for El Monte and Tri-City shall be revoked and tariffs on file referring to El Monte and Tri-City shall be canceled. 3. Golden West Airlines' Certificate of Public Convenience and Necessity shall reflect the name "Mojave Airport" instead of "Kern County Airport No. 7". 4. The restriction in Golden West's certificate prohibiting the operation of aircraft with a seating capacity in excess of 25 passengers shall be modified to provide that the carrier shall not operate aircraft having a seating capacity of more than 30 passengers or a payload in excess of 7,500 pounds. - 2 -

5. Appendix A of Decision No. 77323 is amended by incorporating Fifth Revised Page 1 and Seventh Revised Page 3, attached hereto, in revision of Fourth Revised Page 1 and Sixth Revised Page 3.
