Application of Marvin Bradley Jones, Executor of the Will of Selma K. Jones, deceased, for authority to transfer Elk Grove Water Works to Marvin Bradley Jones, individually, and as Trustee for Helen Frances Roccaforte.

O P I N I O N

Marvin Bradley Jones, also known as Marvin B. Jones, Executor of the will of Selma K. Jones, deceased, seeks authority to transfer Elk Grove Water Works to Marvin Bradley Jones, individually, and as Trustee for Helen Frances Roccaforte.

Selma K. Jones was the owner of Elk Grove Water Works from 1956 until her death on January 12, 1973. Marvin Bradley Jones is the operator and manager of said water system. There will be no interruption in service within the area due to the proposed sale and transfer.

The Superior Court in the county of Sacramento by Order No. 74480 dated December 31, 1973 has authorized the distribution of all Elk Grove Water Works properties, except bank account and certificate of deposit, as provided by the Will of Selma K. Jones, deceased.

The terms of said will provide for distribution of Elk Grove Water Works to Marvin Bradley Jones, individually, one-half interest, and in trust for Helen Frances Roccaforte the remaining one-half interest.

Marvin Bradley Jones, individually and as Trustee for Helen Frances Roccaforte, transferee, will be responsible for the refunds, as they become due and payable, of customers' deposits and subdividers' advances for construction that are held by the utility named herein.

There were no protests to the application, and after consideration the Commission finds that the proposed transfer will not be adverse to the public interest. We further find with reasonable certainty that the projects involved in this proceeding will not have a significant effect on the environment. A public hearing is not necessary.

O R D E R




IT IS ORDERED that:

1. On or before February 1, 1975 Marvin Bradley Jones, Executor, may transfer the water system referred to in the application to Marvin Bradley Jones, individually and as Trustee for Helen Frances Roccaforte, according to the terms and conditions attached to the application.
2. Transferee shall be responsible for all customers' deposits and advances for construction, if any.
3. Within ten days after the completion of the transfer, transferor shall notify the Commission, in writing, of the date of the transfer, of any refunds made, and of the date upon which transferee shall have assumed operation of the water system.

A true copy of the instruments of transfer shall be attached to the notification.

The effective date of this order shall be twenty days after the date hereof.
