Pacific Southwest Airlines has filed Applications Nos. 54992, 54944 and 55024, and Air California has filed Applications Nos. 54878, 54954, 54955, 55009 and 55011. These applications contained duplicate and sometimes triplicate requests for new authority. The Commission finds that these are related questions of law and fact and that the issues in the various applications may be more properly resolved if combined and separated into logical groupings.
