SUPPLEMENTAL OPINION AND ORDER

Minimum Rate Tariff 17-A (MRT 17-A) names minimum rates for the transportation by dump truck carriers of property including rock, sand, gravel and asphaltic concrete. By Decision No. 82992 in Case No. 5437 in Petition for Modification No. 272, rates for the transportation of asphaltic concrete from Los Angeles County Production Area 19-V to various delivery zones were established in MRT 17-A. By Petition for Modification of Decision No. 82992 in this proceeding, California Dump Truck Owners Association further seeks the establishment of zone rates on asphaltic concrete from Production Area 19-V to Delivery Zones 19140 through 19175; 19178 through 19191; and 19372 through 19378.

Petitioner states that, through inadvertence, the aforementioned delivery zones were not included in its original request for the establishment of zone rates from Production Area 19-V. Petitioner avers that the same reasons which formed the basis for Decision No. 82992 exist for promulgating the sought additional zone rates. Petitioner requests that such rates be established on the cost formula applicable to similar asphaltic zone rates in MRT 17-A.

C. 5437 (Pet. 272) - JW Copies of the verified petition were served on various known interested organizations and parties on or about August 12, 1974. The petition was listed on the Commission's Daily Calendar of August 21, 1974. No objection to the granting of the petition has been received. In the circumstances, the Commission finds that the establishment of zone rates to the additional delivery zones will result in just, reasonable and nondiscriminatory minimum rates for the transportation involved. A public hearing is not necessary. The Commission concludes that MRT 17-A should be amended accordingly. IT IS ORDERED that: 1. Minimum Rate Tariff 17-A (Appendix C to Decision No. 80578, as amended) is further amended by incorporating therein, to become effective October 22, 1974, Fourth Revised Page 11-U and Second Revised Page 11-V, attached hereto and by this reference made a part hereof. 2. Common carriers subject to the Public Utilities Act, to the extent that they are subject to Decision No. 80578, as amended, are hereby authorized to establish in their tariffs the amendments necessary to conform with the further adjustments ordered herein. 3. Tariff publications authorized to be made by common carriers as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than the first day after the effective date of this order, and may be made effective on not less than one day's notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order. - 2 -

C. 5437 (Pet. 272) - JW 4. Common carriers, in establishing and maintaining the rates authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations, such outstanding authorizations are hereby modified only to the extent necessary to comply with this order, and schedules containing the rates published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order. 5. In all other respects Decision No. 80578, as amended, shall remain in full force and effect. The effective date of this order shall be October 21, 1974.
