OPINION

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Applicant Vandenberg Limousine Service, Inc., a California corporation, requests authority to extend its passenger stage operations to include service between the Santa Maria Airport and the city of Lompoc. The application was noticed in the Commission's Daily Calendar of July 25, 1974. The application was protested by Greyhound Lines-West which stated that it would withdraw its protest if any grant of authority is restricted to service between the Santa Maria Airport, on the one hand, and, on the other hand, Vandenberg Air Force Base and the city of Lompoc with no local service at intermediate points.

Applicant presently operates between the Santa Maria Airport and the Vandenberg Air Force Base restricted to the transportation of airline passengers and their baggage with no service at intermediate points. Applicant operates in its service 1969 Ford club wagons seating between 8 and 12 passengers which have space for baggage, and are powered with a 205 horsepower engine. This same equipment will be used in the proposed operation. Applicant states that it had a net worth of \$1,839 as of June 30, 1974, and that it had a net operating loss of \$910 for the year ending June 30, 1974. Applicant asserts its time schedules will coordinate with current airline schedules and changes as they occur, meeting both inbound

and outbound airline flights; and since airline schedules are subject to change beyond its control, no definite long-term schedules can be presented. Applicant's practice is to arrive at the airport sufficiently in advance to give passengers ample time for preflight check-in and to depart the airport with a minimum of delay after passenger deplaning and baggage check-out. The total elapsed time per trip between the city of Lompoc, via Vandenberg Air Force Base, to and from the Santa Maria Airport is estimated to be 45 minutes. The fare from the Santa Maria Airport to Vandenberg Air Force Base Will be \$5, to Lompoc \$6, and to South Vandenberg Air Force Base \$8. Applicant asserts that governmental officials have encouraged the use of public transportation as a means of energy conservation and that by extending applicant's service approximately 10 miles, persons residing in or having business in the city of Lowpoc will have the opportunity to utilize this airport bus service. The Santa Maria Airport is the only airport with scheduled commercial airline service that serves the city of Lompoc and Vandenberg Air Force Base.

After consideration the Commission finds and concludes that an in lieu certificate should be issued to applicant to operate as a passenger stage corporation as set out in the ensuing order. The Commission further finds with reasonable certainty that the project involved in this proceeding will not have a significant effect on the environment. The restriction proposed by Greyhound will be imposed.

Applicant is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- 3. The authority granted to applicant by Decision No. 75665 dated May 13, 1969 is cancelled.

The effective date of this order is the date hereof.

- (c) No passengers may be picked up or discharged at intermediate points between Santa Maria Airport, on the one hand, and Vandenberg Air Force Base and the City of Lompoc, on the other hand.
