OPINION

Greyhound Lines, Inc. requests authority to eliminate local transit operations between San Diego and the San Ysidro Port of Entry.

It is alleged that the operations to be eliminated are within the service area of the San Diego Transit District; that the District provides a high level of local service and assesses a fare of 25 cents; and that this has resulted in a preponderance of the traffic being transported by the District.

Applicant will continue to provide an express service between San Diego and San Ysidro Port of Entry over Interstate Highway 5.

Copies of the application were served upon the City Clerks of the cities of San Diego and National City, upon the Board of Supervisors of the county of San Diego, as well as upon the San Diego Transit Corporation. No protest has been received.

After consideration the Commission finds that public convenience and necessity no longer require local service by applicant between San Diego and the San Ysidro Port of Entry. A public hearing is not necessary.

We find with reasonable certainty that the project involved in this proceeding will not have a significant effect on the environment.
