BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of AIRPORT SERVICE, INCORPORATED, a corporation, for authority to extend service between Ontario International Airport, on the one hand, and Fullerton, Laguma Hills, Mission Viejo, Newport Beach, Orange County Airport, Santa Ana and Anaheim Service Area on the other hand, all points in California.

Application No. 54778 (Filed March 29, 1974)

OPINION

Applicant seeks an extension to its certificate of public convenience and necessity in order to establish passenger stage operations between Ontario International Airport, on the one hand, and Fullerton, Laguna Hills, Mission Viejo, Newport Beach, Orange County Airport, Santa Ana, and Anaheim service area in Orange County, on the other hand. The complete route descriptions are attached to the application as Exhibit A, and a map showing part of the existing operating authority in the area and the points proposed to be served are attached thereto as Exhibit B.

The application notes that the route descriptions will allow authority to use the "most direct and appropriate route" between the fixed termini and the intermediate points. The application explains that changing road patterns and changing traffic patterns which vary with the times of day or night make this the most practical way of issuing this type of airport service authority.

The service will be operated on an on-call basis for a minimum of five or more adult fare-paying passengers. Applicant intends to use its existing equipment. Applicant has furnished the Commission staff with an up-to-date equipment list dated July 15, 1974 which, for reference, will be received herein on the Commission's own motion as Exhibit 1. This exhibit shows that applicant currently possesses 58 coaches ranging in seating capacity from 41 to 53 seats (all but one of the coaches have at least 45 seats). Five new coaches were delivered in June and July of this year. The Commission, based upon Exhibit 1, is of the opinion that the applicant has ample equipment to render the proposed service.

A. 54778 eak In support of the application, the applicant states that Laguna Hills, which includes Leisure World and numerous surrounding housing developments, has grown substantially in the last several years, as is the case with the Newport Beach area. Applicant points out that this growth, together with the increasing size of jet planes and the increasing use of the Ontario International Airport, makes the service in here necessary. The applicant states that this application should not compete with any existing passenger stage corporation. No protests have been received. The Finance and Accounts Division has reviewed the applicant's annual report filed on March 26, 1974, and subsequent financial information supplied to it, and is of the opinion that the applicant has the financial ability to render this extension of service. Applicant states that the proposed service will have a beneficial environmental effect in that the number of privately owned automobile trips to and from the airport will be reduced. Findings 1. Public convenience and necessity require granting an extension of applicant's present certificate of public convenience and necessity to establish passenger stage operations between the points and over the routes as fully set forth in Appendix A attached hereto. 2. The proposed fare schedule is reasonable at this time. 3. Applicant has the necessary financial ability, equipment, and personnel to initiate and maintain the proposed service. 4. We find with reasonable certainty that the extension of the certificate of public convenience and necessity involved in this proceeding will not have a significant effect on the environment. -3A. 54778 eak Applicant is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given. ORDER IT IS ORDERED that: 1. A certificate of public convenience and necessity is granted to Airport Service, Incorporated, a corporation, authorizing it to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes set forth in Appendix A, attached hereto and made a part hereof. 2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure so to do may result in a cancellation of the authority. (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules administered by the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series, and the insurance requirements of the Commission's General Order No. 101-Series. -4A. 54778 eak (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office. The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service. The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series. Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe. -5-

3. The certificate of public convenience and necessity granted in paragraph 1 of this order shall supersede the certificate of public convenience and necessity granted by Decision No. 76691 dated January 20, 1970, as amended by Decision No. 76877 dated March 3, 1970, which certificate is revoked effective concurrently with the effective date of the tariff filings required by paragraph 2(b).

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS

The certificate hereinafter noted supersedes all operative authority heretefore granted to Airport Service, Incorporated and Airport Coach Service or their predecessors.

Airport Service, Incorporated (formerly MBF, Inc.), by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport express, passengers and their baggage between certain points and areas in Los Angeles and Orange Counties named herein on the one hand, and to Los Angeles International Airport, Lockheed Air Terminal, Long Beach Municipal Airport, Orange County Airport and Ontario International Airport on the other hand, as well as service between certain of the airports as named herein, over the following described routes and subject to the following conditions and restrictions:

- (a) Carrier shall transport only passengers destined to or originating at the Los Angeles International Airport,
 Lockheed Air Terminal, Long Beach Municipal Airport,
 Orange County Airport and Ontario International Airport.
- (b) Carrier shall not pick up or discharge passengers except at Mission Viejo, Loguna Hills, El Toro Marine Air Station, Long Beach Service Area, Passdena-Monrovia Service Area, Institution Balli, Sell Beach, Newport Beach, Santa Ana, Orenge, Anabeim Service Area, Fullerton, Bucha Park and the Los Angeles Enterpational Airport, Ontario International Airport, Orange County Airport, Long Beach Municipal Airport and the Lockheed Air Terminal.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS (Continued)

- (c) Baggage and express shall be transported in passenger-carrying vehicles only, and limited to a weight of not more than 100 pounds per shipment.
- (d) When route descriptions are given in one direction, they apply to operation in either direction, unless otherwise indicated.
- (e) Motor vehicles may be turned at termini or intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (f) Passengers shall be picked up or discharged only at points and places to be named in corrier's tariff.
- (a) When service is rendered on an "On-Call" basis, tariffs and timetables of the carrier shall show the conditions under which such "On-Call" service will be rendered.
- (h) All passengers originating at or destined to the El Toro Marine Station shall originate at or be destined to the Los Angeles International Airport.
- (i) Service to or from the El Toro Marine Air Station shall be operated for five or more persons.
- (1) Service to or from the El Toro Marine Air Station shall not be operated for less than five persons during the times when regularly scheduled service is operated between Senta Ana and the El Toro Marine Air Station.
- (h) All passengers originating at or destined to the Long Beach Municipal Airport shall originate at or be destined to Huntington Beach, Seal Beach, the Anahelm Service Area, Los Angeles Enternational Airport, Lockheed Air Terminal, Orange County Airport or Ontario International Airport.

 - (1) All passengers originating at or destined to Mission Viejo or Laguna Hills shall originate at or be destined to Los Angeles International Airport or Orange County Airport.

SECTION 2. DESCRIPTION OF SERVICE TERRITORIES

Long Beach Service Area

Commencing at the junction of the San Gabriel River and Artesia Boulevard in Lakewood; thence along Artesia Boulevard, Alameda Street, Henry Ford Avenue to junction of Henry Ford Avenue and City Limits of Long Beach; thence along City Limits of Long Beach and west boundary of the U. S. Naval Base south to the ocean; thence east along the shoreline of Long Beach Harbor and Long Beach to the junction of the shoreline and outlet of the San Gabriel River; thence north along the San Gabriel River to the point of beginning.

Pasadena-Monrovia Service Area

Commencing at the intersection of Loma Alta Drive and Lincoln Avenue; thence along Lincoln Avenue, Montana Street, Arroyo Boulevard, York Boulevard, Monterey Road, Fremont Avenue, Alhambra Road, Garfield Avenue, Main Street, Las Tunas Drive, Live Oak Avenue, Myrtle Avenue, Duarte Road, Mountain Avenue, Foothill Boulevard, Santa Anita Avenue, Sierra Madre Boulevard, Washington Boulevard, Altadena Drive, Lake Avenue, Loma Alta Drive to point of beginning.

Ansheim Service Area

The Anaheim Service Area is that portion of the City of Anaheim, the City of Garden Grove, the City of Orange and Orange County that is bounded as follows: On the north by Lincoln Avenue, on the west by Brookhurst Street, on the south by Chapman Avenue and on the east by the Santa Ana River; all streets, inclusive.

Subject to the authority of this Commission to change or modify such at any time, Airport Service, Incorporated shall conduct its passenger stage operations between the following points and over and along the following described routes:

Route 1 - Newport Beach - Anaheim Service Area

Commencing at the Newporter Inn, Jamboree Road and Pacific Coast Highway, Newport Beach to Pacific Coast Highway, Newport Avenue, Harbor Boulevard to the Anaheim Service Area and over and along the most direct or appropriate route(s) on to the San Diego Freeway, Century Boulevard and to the Los Angeles International Airport.

Alternate Route - Fullerton - Buena Park

Commencing from the Anaheim Service Area to north on Anaheim Boulevard, Harbor Boulevard, Commonwealth Avenue, Maiden Avenue, Whiting Avenue to the Villa del Sol, 305 North Harbor Boulevard, Fullerton, continue on Harbor Boulevard to the Riverside Freeway, Artesia Freeway to Holiday Inn, 7000 Beach Boulevard, Buena Park and over and along the most direct or appropriate route(s) to the Los Angeles International Airport, subject, however, to local traffic regulations.

Route 2 - El Toro Marine Air Station

Commencing at El Toro Marine Air Station via the most direct or appropriate route(s) to the los Angeles International Airport.

Alternate Route - Santa Ana

Commencing at El Toro Marine Air Station, to Trabuco Road, Santa Ana Freeway, to Suddleback Inn, 1660 East First Street, Santa Ana and over the most direct or appropriate route(s) to the Los Angeles International Airport.

II. LOS ANGELES INTERNATIONAL AIRPORT - LOCKHEED AIRPORT TERMINAL OPERATIONS

Route 1 - Long Beach Service Area

Commencing from Long Beach Service Area, west on Artesia Boulevard, Earbor Freeway, Century Boulevard, Los Angeles International Airport, Century Boulevard, Airport Boulevard, La Tijera Boulevard, Slauson Avenue, La Brea Avenue, Edgewood Place, Highland Avenue, Cahuenga Boulevard, Hollywood Freeway, Barbam Boulevard, Olive Avenue, Hollywood Way and to Lockheed Air Terminal.

Service between Los Angeles International Airport and Lockheed Air Terminal may be operated on an "On-Call" basis.

Alternate Route 1 - Crenshaw Boulevard - Los Angeles International Airport

Commencing from the Long Beach Service Area, west on Artesia Boulevard, 174th Street, Crenshaw Boulevard, Century Boulevard and to Los Angeles International Airport.

Route 2 - Santa Ana

Commencing at the Saddleback Inn, 1660 East First Street, Santa Ana and via the most direct and appropriate route to the airline passenger terminal at Ontario International Airport.

Alternate Route - Anaheim Service Area

Commencing at the Saddleback Inn, 1660 East First Street, Santa Ana, via the most direct and appropriate route to the Anaheim Service Area and thence over the most direct and appropriate route to the airline passenger terminal at Ontario International Airport.

Route 5 - Pasadena - Monrovia Service Area.

Commencing from the Pasadena-Monrovia Service Area to Huntington Drive, Foothill Boulevard, Azusa Avenue, San Bernardino Freeway, Vineyard Avenue and to the airline passenger terminal at Ontario International Airport.

Route 6 - Long Beach Service Area

Commencing from the Long Beach Service Area to Long Beach Freeway, San Bernardino Freeway, Vincyard Avenue and to the airline passenger terminal at Ontario International Airport.

Alternate Route 1 - Riverside Freeway

Commencing from the Long Beach Service Area to San Diego Freeway, Garden Grove Freeway, Newport Freeway, Riverside Freeway, California State Highway 71, Euclid Avenue, Holt Avenue, Vineyard Avenue and to the airline passenger terminal at Ontario International Airport.

Commencing from the Anaheim Service Area via the most direct and appropriate route to the airline passenger terminal at the Long Beach Municipal Airport.

Commencing at the Hilton Inn, 25205 La Paz Road at the intersection of Mission Viejo, La Paz Road, Interstate Highway 5, El Toro Road, Avenue de la Carlota, Paseo de Valencia to the Hyatt Laguna Hills Motel, 23932 Paseo de Valencia, Laguna Hills, continue on Paseo de Valencia, Avenue de la Carlota, El Toro Road, Santa Ana Freeway, San Diego Freeway, MacArthur Boulevard, Campus Drive and to the Orange County Airport. Service between Orange County Airport and Los Angeles International Airport will be rendered over routes presently authorized between the two airports.
