ORDER DENYING REHEARING

4. Minimum Rate Tariff 19 (Appendix A to Decision No. 41363, as amended) is further amended by incorporating therein to become effective February 3, 1975, Supplement 29 attached hereto and by this reference made a part hereof.

5. Tariff publications required or authorized to be made by common carriers as a result of the order herein may be made effective not earlier than the first day after the effective date of this order, on not less than one day's notice to the Commission and to the public; such tariff publications as are required shall be made effective not later than February 3, 1975, and as to tariff publications which are authorized but not required, the authority shall expire unless exercised within sixty days after the effective date of this order.


