ORDER_DELETING NONSTOP BURBANK-SACRAMENTO AUTHORITY On December 11, 1974 Pacific Southwest Airlines (PSA) petitioned for a one year suspension of its nonstop service between Hollywood-Burbank and Sacramento, and for authority to operate only one-stop round-trip service between Burbank and Sacramento. Alternatively, PSA cites Section 2769.5 of the Public Utilities Code which allows for discontinuance of an unprofitable operation upon 60 days' notice, unless within such 60-day period, the Commission finds after hearing that the operation is profitable and orders its continuance. Nonstop authority between Burbank and Sacramento is set forth in Routes 15 and 20 of PSA's Certificate of Public Convenience and Mecessity and one-stop authority is set forth in Route 17 PSA's load factor on its nonstop Burbank-Sacramento flights is currently 25% or less. Its current public flight schedule provides 42 weekly nonstop flights in each direction between Los Angeles International Airport and Sacramento. Deletion of this service would conserve energy and reduce the operating costs of the carrier. We conclude that the route should be deleted rather than suspended since PSA has had an opportunity to develop the nonstop service and certification should not be continued for an air carrier that is not actually providing the service.

A. 51058 FBC* ORDER IT IS ORDERED that: 1. Pacific Southwest Airlines' nonstop authority between Hollywood-Burbank and Sacramento is hereby deleted from its Certificate of Public Convenience and Necessity. 2. Appendix A of Decision No. 79085 is amended by incorporating Second Revised Page 2 and Fourth Revised Page 5 in revision of First Revised Page 2 and Third Revised Page 5.
