ORDER REVOKING WAREHOUSE OPERATIVE RIGHTS

Haslett Company (formerly Haslett Warehouse Company) possesses operative rights as a public utility warehouseman for the operation of storage or warehouse floor space at Stockton, Sacramento, West Sacramento, Fowler and San Francisco.

Don Haslett, Vice President of Haslett Company, has informed the Commission by letter that public warehouse operations have not been conducted at the aforementioned locations for some time. He requests that the cold storage operative rights at San Francisco and the operative rights at the other locations described above be revoked.

In the circumstances, the Commission finds that revocation of the warehouse operative rights, as requested, would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the warehouse operative rights should be revoked and the tariffs applicable to the services thereunder should be canceled.

IT IS ORDERED that:

1. The certificate of public convenience and necessity for the cold storage warehouse operation at San Francisco granted to Haslett Company, a corporation, by Decision No. 39169 dated July 1, 1946, as amended by Decision No. 70957 Dated July 12, 1966, in Application No. 27614 is hereby revoked.

2. The prescriptive operative right as a public utility warehouseman possessed by Haslett Company, a corporation, for the operation of warehouse or storage space at Fowler, Stockton and West Sacramento as determined by the Commission's order dated July 12, 1960, in Case No. 6610, as amended by Decision No. 70957 dated July 12, 1966, in said proceeding is hereby revoked.

3. The operative right possessed by Haslett Company, a corporation, for the operation of warehouse or storage space at Sacramento is hereby revoked.


4. Jack L. Dawson, Agent, is hereby directed to cancel the participation of Haslett Company from the involved tariffs of California Warehouse Tariff Bureau on file with the Commission, such cancellation to be made within ninety days after the effective date of this order and on not less than ten days' notice to the Commission and to the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Haslett Company, or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to Jack L. Dawson, Agent.
