Complainants' request that the Commission issue an order requiring defendant to cease and desist alleged unauthorized common carrier service. Hearing in this matter was held February 20, 1975 before Examiner Charles E. Mattson in Los Angeles, California.

No new evidence was presented at the hearing of February 20, 1975. Counsel for complainants relies upon the evidence before the Commission in Application No. 54320. Counsel for defendant agreed to submission upon the pleadings in this complaint case and the evidence and pleadings in Application No. 54320. Findings

1. Complainants herein appeared as protestants in Application No. 54320.

2. Defendant appeared as the applicant in Application No. 54320.

3. Complainants seek an order requiring defendant to cease and desist alleged unauthorized common carrier service. Complainants rely upon the evidence of record in Application No. 54320.

4. By Decision No. 84148 dated March 4, 1975 in Application No. 54320 we found that applicant's activities have not rendered it unfit to be granted the certificate requested (Decision No. 84148, page 10, paragraph 7). Decision No. 84148 granted highway common carrier authority to defendant.

5. The certificate granted authorized operations over the routes which are in issue in this complaint case.

6. The evidence in Application No. 54320, for the reasons  $\sqrt{}$  set forth in Decision No. 84148, does not support the claim that defendant has acted in disregard of the provisions of the Public Utilities Code or of the regulations of this Commission.
