ORDER MODIFYING DECISION NO. 84166

Decision No. 84166 dated March 4, 1975 in this proceeding authorized applicant to increase all rates charged for water service. It is now apparent that the 1974 estimated operating revenue at present rates, computed by the staff in the revenue tables on page 4 of said decision was inadvertently listed as \$75,700. The correct estimate is \$73,900. It is also evident that Finding 5 and the Appendix of said decision will have to be changed since they are based on the revenue estimate.

## IT IS ORDERED that:

1. Seventy-three thousand nine hundred dollars is substituted in place of \$75,700 as the 1974 staff estimate of operating revenue at present rates.

2. Finding 5 is deleted from Decision No. 84166 and the following finding is substituted therefor:

"5. Present rates would produce an operating revenue of \$73,900, based on the 1974 test year. A 14.6 percent increase will be authorized to provide \$10,600 of additional revenue and total revenue of \$84,700."

3. Appendix A of Decision No. 84166 is canceled and the Appendix A attached to this order is substituted therefor. After the effective date of this order, Campton Heights Water Service is authorized to file the revised rate schedules attached to this order as Appendix A. Such filing shall comply with General Order No. 96-A.

The effective date of the revised schedules shall be four days after the date of filing. The revised schedules shall apply only to service rendered on and after the effective date thereof.

4. The increase in rates authorized by this order is \$1,800; the rate of return found reasonable in Decision No. 84166 remains the same.

5. The increases in rates and charges authorized by this decision are justified and are reasonable; and the present rates and charges, insofar as they differ from those prescribed by this decision, are for the future unjust and unreasonable.

In all other respects Decision No. 84166 shall remain in full force and effect.

The effective date of this order is the date hereof.

## Schedule No. 2R

RESIDENTIAL FLAT RATE SERVICEAPPLICABILITY

Applicable to all flat rate residential water service.

TERRITORY

Rohnerville, including Campton Heights Subdivision, and vicinity,  
Humboldt County.

RATES

Per Service Connection  
Per Month

For a single-family residence, exclusive of any lawn or garden irrigation .....	\$5.60	(I)
In addition, for irrigation of lawn and garden areas, not to exceed six months annually .....	2.85	(I)

SPECIAL CONDITIONS

1. The above flat rates apply to a service connection not larger than one inch in diameter.
2. If the utility so elects, a meter shall be installed and service provided under Schedule No. 1, Metered Service.
3. All service not covered by the above classification will be furnished only on a metered basis.
