In the Matter of the Application of DEL ESTE WATER COMPANY, a corporation, for an order authorizing it to increase rates charged for water

Application No. 55202 (Filed September 25, 1974; amended February 27, 1975)

INTERIM OPINION

Del Este Water Company, a corporation, is engaged in the business of the supply and distribution of water for domestic and industrial purposes in the suburban Modesto area and in portions of the communities of Waterford, Empire, Salida, Turlock, Hillcrest, Hickman, and Grayson. By this application it seeks authority to increase its rates. By amendment to its application it requests emergency interim authority to increase its rates by approximately 26 percent.

Applicant asserts that the interim increases in rates will provide \$247,731 in additional gross revenues which amount is necessary for applicant to meet current long-term debt coverage, to restore normal payroll, to return to normal repair and maintenance practices, to restore dividend payments, and to recommence work in progress, as well as enable it to qualify for needed additional longterm debt.

The amended application sets forth the results of coplicant's operations for the year 1974 together with adjustments to reflect anticipated results under present rates and under the proposed interim rates for a future rate year.

The Commission staff made an examination of applicant's 1974 books of account and has submitted a report of its findings and conclusions with respect to such examination. The report is received in evidence as Exhibit 1.

There are minor differences in the statements of the staff and applicant respecting the actual results of 1974 operations. The pro forma results for a future rate year under present rates anticipated by applicant and the staff differ substantially and therefore there are issues regarding the appropriate estimates of revenues and expenses that can be resolved only after public hearing. Exhibit 1 shows, however, that considering the staff's estimates of additional revenues and expenses there would be serious inroads upon applicant's earnings ability such that its interest coverage (after taxes) would fall from 1.43 to .89 so that its net operating income will not cover its interest costs.

The staff suggests that applicant is facing a financial emergency. It recommends that applicant be authorized to increase its rates 6.7 percent on an interim basis which would provide \$63,627 additional revenues. That recommended increase is approximately onefourth of applicant's requested interim relief. The staff asserts that the increase of \$63,627 is necessary to raise the applicant's interest coverage to 1.7 times earnings and that this coverage ratio would allow the company to fully cover its operating expenses and fixed charges, strengthen its credit position, and provide a small cushion for unexpected costs which may arise during the interim period.

The differences in the projections by applicant and the staff constitute issues regarding reasonable and appropriate projections of revenues and expenses for a future rate year. We must resolve those issues against applicant pending public hearing and therefore at this time, for the purpose of evaluating the justification for emergency increases in rates pending public hearing, we adopt the staff's projections which are set forth below:

We find that:

1. Applicant's present rates will not return to it sufficient revenues for it to meet its financial obligations and that interim rate relief is necessary to maintain the efficiency, safety, and adequacy of water service in the area served by applicant.

2. Interim rate increases' that will provide \$63,627 in additional gross revenue is the minimum that will permit applicant to continue operations on a reasonably sound financial basis.

3. The increased interim rates set forth in Appendix A, attached hereto, will provide applicant reasonable opportunity to recover \$63,627 additional revenues; the increases in rates and charges represented therein are justified and are reasonable; and the present rates and charges, insofar as they differ from those prescribed therein, are for the future unjust and unreasonable.

4. At this time, and pending further proceedings in this application, applicant has not shown that increases in rates greater than those set forth in Appendix A are justified.

We conclude that pending further decision herein applicant should be authorized to establish as interim rates the increased rates set forth in Appendix A.

INTERIM ORDER

IT IS ORDERED that:

1. Del Este Water Company, a corporation, is authorized to file the revised interim rate schedules attached to this order as Appendix A. Such filing shall comply with General Order No. 96-A. The effective date of the revised schedules shall be five days after the date of filing and the revised schedules shall apply only to service rendered on and after the effective date of the revised schedules.

- b. Service connections to commercial or business establishments.
- c. Service connections for agricultural purposes.
- d. Service connections to premises containing multiple dwellings or dwellings and occupied trailer houses.

PRIVATE FIRE PROTECTION SERVICE

APPLICABILITY

Applicable to all water service furnished to privately owned fire protection systems.

TERRITORY

Portions of Modesto and Turlock, and Empire, Salida, Waterford, Hickman, Grayson, and Hillcrest and vicinity, Stanislaus County.

RATE

Por Month

For each inch of diameter of service connection \$1.44 (I)

SPECIAL CONDITIONS

1. The fire protection service connection shall be installed by the utility and the cost paid by the applicant. Such payment shall not be subject to refund.

2. The minimum diameter for fire protection service shall be four inches, and the maximum diameter shall be not more than the diameter of the main to which the service is connected.

3. If a distribution main of adequate size to serve a private fire protection system in addition to all other normal service does not exist in the street or alley adjacent to the premises to be served, then a cervice main from the nearest existing main of adequate capacity shall be installed by the utility and the cost paid by the applicant. Such payment shall not be subject to refund.

SPECIAL CONDITIONS-Contd.

4. Service hereunder is for private fire protection systems to which no connections for other than fire protection purposes are allowed and which are regularly inspected by the underwriters having jurisdiction, are installed according to specifications of the utility, and are maintained to the satisfaction of the utility. The utility may install the standard detector type meter approved by the Board of Fire Underwriters for protection against theft, leakage or waste of water and the cost paid by the applicant. Such payment shall not be subject to refund.

5. The utility undertakes to supply only such water at such pressure as may be available at any time through the normal operation of its system.

6. The cost of the vault, check valves and appurtonances thereto shall be paid by applicant. Such payment shall not be subject to refund. Upon installation such facilities shall become the property of the utility, and applicant shall advise utility of the cost thereof if installed by applicant.

PUBLIC FIRE HYDRANT SERVICE

APPLICABILITY

Applicable to all fire hydrant service furnished to municipalities, organized fire districts and other political subdivisions of the State.

TERRITORY

Portions of Modesto and Turlock, and Empire, Salida, Waterford, Hickman, Grayson, and Hillcrest and vicinity, Stanislaus County.

RATES

SPECIAL CONDITIONS

1. Water delivered for purposes other than fire protection shall be charged for at the quantity rates in Schedule No. 1, Metered Service.

2. The cost of relocation of any hydrant shall be paid by the party requesting relocation.

3. Hydrants shall be connected to the utility's system upon receipt of written request from a public authority. The written request shall dosignate the specific location of each hydrant and, where appropriate, ownership, type and size. (Continued)

SPECIAL CONDITIONS-Contd.

4. The utility undertakes to supply only such water at such pressure as may be available at any time through the normal operation of its system.

5. The cost of maintenance of all hydrants will be borne by the utility except that painting of and weeding adjacent to hydrants will be borne by the fire protection agency.
