SUPPLEMENTAL ORDER

Decision No. 84122 dated February 19, 1975 in this proceeding authorized G.C.T., Inc. (GCT) to purchase the Anderson Cartage (Anderson) operating authority and equipment. GCT filed a request by letter dated April 4, 1975 for an order canceling Anderson's participation in all tariffs and to transfer all authority formerly held by Anderson to GCT by adding the Anderson Authority to tariffs participated in by GCT. This transfer may result in a slight increase in some of the GCT rates. We hereby find that any increases resulting therefrom are justified and reasonable.

IT IS ORDERED that:

1. G.C.T., Inc., a corporation, is hereby authorized to cancel the Anderson Cartage Local Freight Tariff 1-A and all of Anderson Cartage's participation in tariffs SO 9, FT 11, ES 1, LFT 14, and LFT 16, issued by O. R. Thomasson, Agent, Pacific Motor Tariff Bureau, Inc., and to have the former Anderson Cartage's participation added to the G.C.T., Inc. tariffs issued by Western Motor Tariff Bureau, Inc., Agent, as specifically proposed in the April 4, 1975 letter previously described.

2. Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public.

3. The effective date of the Pacific Motor Tariff Bureau, Inc., tariff publication authorized herein shall be concurrent with the effective date of the Western Motor Tariff Bureau, Inc., tariff publications authorized herein.

4. Western Motor Tariff Bureau, Inc., in establishing and maintaining the tariff publications authorized hereinabove, is hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the tariff amendments published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

5. The authority granted by the order herein shall expire unless exercised within one hundred twenty days after the effective date of this order.
