<u>O P I N I O N</u>

Devine & Son Trucking Co., a corporation, is authorized to operate as a highway common carrier for the transportation of general commodities, with certain specified exceptions, between points in northern California. This certificated authority was granted by Decision No. 59847 dated March 20, 1960 and has been thrice amended.

By this application, applicant requests that its certificate be further restricted to preclude the transportation of wood shavings, wood pieces and sawdust as a highway common carrier. The applicant, in a letter dated April 3, 1975, which clarifies the request, states that because of the specialized services it provides in transporting these commodities, it needs the flexibility to adjust its rates on short notice.

A copy of this application was served upon the California Trucking Association and was listed on the Commission's Daily Calendar for February 20, 1975. No protests have been received.

The Commission finds that public convenience and necessity no longer require applicant's services as a highway common carrier for the performance of the transportation service involved and concludes that the application should be granted. A public hearing is not necessary.

Devine & Son Trucking Co., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport lumber and forest products (except sawdust, as that commodity is described in Item 113200, National Motor Freight Classification 100-B, effective April 1, 1975):

Between all points and places on the following described highways:

- (1) U.S. Highway 101 between the California-Oregon State Line and Santa Barbara, inclusive;
- (2) U.S. Highway 99, 99E and 99W between the California-Oregon State Line and the intersection of said highways with State Highway 138 near Gorman, inclusive;
