OPINION AND ORDER

By this application, Airborne Freight Corporation seeks authority to cancel pickup and delivery service at Travis Air Force Base from the List of Points which it serves as provided in Airborne's Official Airfreight Forwarder California Intrastate Rate Tariff, Cal.P.U.C. No. 1.

Applicant states that, at the present time, it is not receiving shipments at Travis Air Force Base as such shipments are brought into its facility at San Francisco International Airport by a local truck line. Applicant avers that it generally delivers one shipment per trip to the base two or three times per week and the average weight and revenue from these shipments are respectively 100 pounds and \$9.75 while the cost of performing the service is approximately \$75.00.

Applicant believes that other carriers, which have the Volume of business to justify competitive rates, are providing service to and from Travis Air Force Base at charges lower than those assessed by it.

The application was listed on the Commission's Daily Calendar of January 21, 1975. The Traffic Management Officer of Travis Air Force Base has informed the Commission by letter that the base has no objection to the granting of the application.

In the circumstances, the Commission finds that applicant's proposal is justified and discontinuance of service at Travis Air Force Base would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the application should be granted.

IT IS ORDERED that:

1. Airborne Freight Corporation is hereby authorized to eliminate Travis Air Force Base from the List of Points served in its Official Airfreight Forwarder California Intrastate Rate Tariff, Cal.P.U.C. No. 1.

2. Tariff publications authorized to be made as a result of the order shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public.

3. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.

This order shall become effective twenty days after the date hereof.
