Decision No. <u>84749</u>

OPINION

This is an application by The Gray Line Tours Company (Gray Line) seeking a modification of its operating authority "to enable it to render to the sightseeing public a service responsive to present highway conditions and presently established points of interest."

A duly noticed public hearing was held in this matter before Examiner Donald B. Jarvis in Los Angeles on June 19, 1974, and it was submitted on July 12, 1974.

In Decision No. 81036 in Application No. 49177 and related Applications Nos. 49980 and 50434 the Commission, among other things, granted Gray Line an in lieu certificate of public convenience and necessity which restated Gray Line's passenger stage sightseeing operating authority. (The Gray Line Tours Co. (1973) 74 CPUC 669.) In Decision No. 81036 we indicated that the matter had been made unduly complex because of the manner in which Gray Line presented its case. (74 CPUC at p. 680.) We rejected requests by Gray Line and the Commission staff (staff) to reopen and further enlarge those proceedings and stated that: "If, after the modifications hereinafter made, additional relief is deemed necessary it may be secured by an appropriate application, complaint, or order instituting investigation setting forth the particular issue or factual situation involved in the light of the determinations made herein." (74 CPUC at p. 682.) The present application was filed in response to this language.

The material issue presented herein is whether Gray Line's sightseeing operating rights should be modified?

Gray Line seeks to eliminate from its operating authority certain tours which it believes are impractical or have no present sightseeing value. Decision No. 81036 sought to eliminate abandoned and defunct authority from Gray Line's operating rights. (74 CPUC at pp. 708, 711.) There are no objections to those portions of this application which seek to further implement that result. As a consequence of eliminating abandoned or defunct authority, Gray Line seeks to renumber the remaining items and tours in the in lieu certificate attached as Appendix A to Decision No. 81036. To the extent renumbering effectuates no substantive changes, it should be authorized.

All item and tour numbers hereinafter mentioned refer to the certificate of public convenience and necessity set forth in Appendix A of Decision No. 81036, unless the contrary is indicated.

Orange Coast Sightseeing Company (Orange Coast) and Airport Service, Inc. (Airport Service) appeared as parties to protest the application. Orange Coast's points of protest were mooted when Gray Line filed its first amended application and made certain amendments by interlineation at the hearing. Airport Service's protest is based upon the contention that Decision No. 81036 overlooked the fact that it operated between Los Angeles International Airport, on the one hand, and, on the other hand, Long Beach and its Pasadena-Monrovia Service Area. It opposes a restatement of Item 15 unless Gray Line is prohibited from originating passengers from the airport to these areas or, in the alternative, prohibited from originating any passengers at Los Angeles International Airport. The Commission is of the opinion that consideration of the point sought to be raised by Airport Service is not appropriate to this proceeding. (Scott Transportation Co. (1957) 56 CPUC 1.)

The staff objected to proposed Items 330, 345, 410, 415, and 739. The objection to these items is based on the staff's contention that specific points of interest should be delineated in these items.

Proposed Item 330 is a restatement of present Item 330 and is in the language of prior operating authority restated in Decision No. 81036. The proposed changes deal with conditions of service. Under the present item a minimum of 15 fares is required for Gray Line to operate the tour. Under the proposed item Gray Line would have the option to operate the tour with less than 15 fares, a proposal in the public interest. There is no evidence, however, which would justify, a finding changing the tour description.

Proposed Item 345 is a combination of two tours presently authorized as Items 345 and 350 into one tour. The tours sought to be combined are two similar tours from Los Angeles to San Diego. The record indicates that portions of each of the presently authorized tours have no current sightseeing interest. Because of the similarity of the tours, combining them into one tour would not be adverse to the public interest. Proposed Item 345 describes the tour provided for therein in language substantially similar to that used in present Items 345 and 350. There is no evidentiary basis in the record which would justify a finding changing the description of proposed Item 345.

Proposed Item 410, a tour from Los Angeles to Lake Arrowhead, differs from the present one in that it eliminates specific route descriptions between the points. The record indicates that the reason for the proposed change is that the primary attraction of the tour is Lake Arrowhead and not points enroute. There is no evidence that the Lake Arrowhead tour is in a competitive market and that changing the emphasis of a presently authorized carrier would work to the detriment of any other sightseeing operator. In the circumstances, we do not see why proposed Item 410 should not be authorized. (See 74 CPUC at pp. 691-92.)

Proposed Item 415 involves a situation similar to that discussed with respect to proposed Item 410. In proposed Item 415, a tour from Los Angeles to Palm Springs, Gray Line seeks to eliminate a specific route description between the points. Again, Gray Line seeks to change the thrust of a presently authorized tour, in a non-competitive situation, to emphasize the destination point and environs rather than points along the route. The record indicates that since the initial grant of specific route authority contained in present Item 415, various freeways have been constructed which provide quicker and more expeditious access between Los Angeles and Palm Springs.

In addition, Palm Springs has grown, and there are more points of sightseeing interest in and about Palm Springs, including the Palm Springs Aerial Tram. Again, we do not see why the proposed change should not be authorized.

Proposed Item 739 is a modification of presently authorized Item 730, a tour from San Diego and Coronado to Los Angeles. presently authorized tour contains three alternate route descriptions. The alternate routes have a common portion calling for operations from San Diego-Coronado over the Pacific Coast Highway, through La Jolla, Del Mar, Cardiff, Carlsbad, Oceanside, and San Clemente to Capistrano Beach. Gray Line's general manager testified that the demand for the tour focuses on Knott's Berry Farm, Disneyland, and attractions in Los Angeles such as Farmer's Market, Hollywood Bowl, Chinese Theater, etc.; passing through the points on the Pacific Coast Highway takes away time which patrons would rather spend elsewhere and that proposed Item 739 is an attempt to modernize the tour. Under the proposed item, Gray Line intends to operate over the San Diego Freeway. Thus, patrons who desire to debark at Knott's Berry Farm and Disneyland, and be picked up later in the day when the bus passes the attraction on its return trip, will be afforded a greater length of time at the attraction.2/

The staff does not object to the change in emphasis of the tour. It does, however, object to the language of proposed Item 739. The basis for the objection is that the language is so broad that it preempts the Pacific Coast Highway, even though Gray Line does not propose to operate through La Jolla, Del Mar, and other beach cities on that route. We believe the staff's objection has merit. In Decision No. 81036, the Examiner's proposed report, adopted by the Commission, stated: "The grant of such authority would establish

^{4/} The Commission takes official notice that the Pacific Coast Highway is coextensive with San Diego Freeway from Oceanside to Capistrano Beach.

Gray Line as the existing carrier, within the meaning of Section 1032, in a vast area of Southern California, with a minimal commitment to render service. It would tend to stifle competition and the development of tourism in these areas. It is, of course, in Gray Line's interest to develop additional tours which are profitable. However, others may visualize tours not apparent to Gray Line or be able, because of their proximity or connections in an area, to develop tours which Gray Line cannot operate economically. The innovative will be met with the contention that under Section 1032 the existing carrier must first be afforded an opportunity to place the idea in effect to the satisfaction of the Commission, and only upon a failure to do so, will the originator be afforded an opportunity to establish the tour." (74 CPUC at p. 700.) We believe that principle is applicable to the tour here in question. Unlike some of the item revisions heretofore considered, we do not find that the beach cities near San Diego are a noncompetitive area. We believe that there may be sightseeing potential from San Diego through these cities.

Protestant, Greyhound Lines, Inc., Western Division (Greyhound), also objected to proposed Item 739. Greyhound contends that proposed Item 739 could divert some of its passenger stage operations between San Diego and Disneyland. There is no merit in this protest. Greyhound offered no evidence at the hearing. Its position is based solely on conjecture. (Compare, The Gray Line Tours Co. (1971) 72 CPUC 687.) Balanced against the conjecture is the fact that Gray Line presently has the authority to serve between San Diego and Disneyland. Proposed Item 739 enables a customer to spend more time at Disneyland by eliminating time spent passing through the beach cities, and the record indicates a demand for such service. Furthermore, the service presently operated and that proposed by Gray Line is of a different character and at higher rates than that provided by Greyhound. (See 74 CPUC 690-92.) The Commission is of the opinion

that Gray Line should be permitted to shift the emphasis of the tour, but the language of proposed Item 739 will be modified to preclude preemption of the beach cities.

No other points require discussion. The Commission makes the following findings and conclusion. Findings of Fact

- l. The tours which Gray Line seeks to eliminate from its operating authority are ones which have no present sightseeing value. Eliminating these tours from Gray Line's certificate of public convenience and necessity is consonant with Decision No. 81036.
- 2. Proposed Item 330 is a restatement of present Item 330 and is in the language restated in Decision No. 81036. The proposed changes deal with conditions of service. There is no evidentiary basis which would justify changing the tour description. The public will benefit if Gray Line is given the authority to, at its option, operate the tour with less than 15 fares.
- 3. Proposed Item 345 is a combination and consolidation of two tours presently authorized as Items 345 and 350. Presently authorized Items 345 and 350 are similar tours from Los Angeles to San Diego. Portions of the presently authorized tours have no current sightseeing interest. The public will benefit if Gray Line is authorized to combine and consolidate present Items 345 and 350, deleting therefrom points which have no present sightseeing value. Proposed Item 345 describes the tour provided for therein in language substantially similar to that used in present Items 345 and 350. There is no evidentiary basis which would justify changing the description of proposed Item 345.

- 4. Proposed Items 410 and 415 seek to change the emphasis of presently authorized tours. In each instance, Gray Line seeks to eliminate specific route descriptions so that it can take the most expeditious route and concentrate the sightseeing in and about the point of destination. Proposed Items 410 and 415 are not in a competitive market. Authorizing the proposed items will benefit the public and not work to the detriment of any other sightseeing operator.
- 5. Proposed Item 739 is a modification of presently authorized Item 730, a tour from San Diego and Coronado to Los Angeles. The presently authorized tour contains three alternate route descriptions. The alternate routes have a common portion calling for operations from San Diego-Coronado over the Pacific Coast Highway, through La Jolla, Del Mar, Carlsbad, Oceanside, and San Clemente to Capistrano Beach.
- 6. Gray Line has the authority in presently authorized Item 730 to debark passengers at Knott's Berry Farm and Disneyland and pick them up later in the day when the tour bus passes the attraction on the return trip. Many of Gray Line's passengers prefer to spend more time at Knott's Berry Farm and Disneyland than to see La Jolla, Del Mar, and other beach cities. Proposed Item 739 would afford such patrons this opportunity.
- 7. The beach cities are in a competitive or potentially competitive market. Proposed Item 739 is too broad in that it preempts the beach cities under Section 1032, while Gray Line does not propose to offer service through these cities. Proposed Item 739 should be modified as follows:

Proposed Item No. 739 (Proposed Tour No. S-5):

San Diego and Coronado-Los Angeles: Leaving the Cities of San Diego and Coronado via the San Diego Freeway (U.S. Interstate Highway No. 5) to Capistrano Beach, thence via the most appropriate and scenic routes to the City of Los Angeles, and return, visiting points of interest such as Knott's Berry Farm and Disneyland.

NOTE: Passengers so desiring may be given the option to debark at Knott's Berry Farm or Disneyland without completion of the outbound tour to Los Angeles and be picked up on return of said tour or by other available vehicles.

- 8. The type of sightseeing service presently performed by Gray Line from San Diego-Coronado to Disneyland under Item 730 and that sought under proposed Item 739 is different than the intercity passenger stage service performed by Greyhound between those points. There is no evidence to indicate that if proposed Item 739 is authorized there will be any diversion of intercity passenger stage traffic of Greyhound.
 - 9. Proposed Item 739, as herein modified, should be authorized.
- 10. There is no evidentiary basis which would justify changing Item 15 other than to reflect the renumbering of items and tours and the changes in operating authority provided for in other findings of fact herein. The matters raised herein by Airport Service were determined adversely to it in Decision No. 81036.
- 11. Public convenience and necessity require that Gray Line be granted the additional or modified operating authority as hereinafter set forth.
- 12. Gray Line has the ability, including financial ability, to conduct operations under the authority hereinafter granted.
- 13. With reasonable certainty the project involved in this proceeding will not have a significant effect on the environment. Conclusion of Law

The application should be granted as hereinafter set forth.

- (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules administered by the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series, and the insurance requirements of the Commission's General Order No. 101-Series.
- (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service.

- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.
- (a) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- 3. The certificates of public convenience and necessity granted in paragraph 1 of this order shall supersede the certificates of public convenience and necessity granted by Decisions Nos. 67371, 72992, 74421, 77672, 79603, 81036, 81539, 82693, and 83823, which certificates are revoked effective concurrently with the date of filing of the written acceptance required by paragraph 2(a).

The effective date of this order shall be twenty days after the date hereof.

SECTION I, General Authorizations

Round-trip Service: Except as otherwise specifically provided herein, The Gray Line Tours Company is only authorized to provide round-trip sightseeing operations.

Authorized Routes and Points: Where authority is granted herein for a specified route, The Gray Line Tours Company shall conduct operations over such route and not deviate therefrom without authority from this Commission. In the event of an act of God (flood, fire, etc.), accident, road repairs or other temporary situation which makes a route impassable, The Gray Line Tours Company may make reasonable, temporary deviations from such route, subject to any applicable rules, regulations or conditions which may be imposed by the public entity which has jurisdiction over the streets where such deviation may be made.

For operating convenience and to avoid congestion at scenic attractions, The Gray Line Tours Company may alter the order of points visited on a specific route.

Where authority is granted herein for service between or among points, The Gray Line Tours Company shall conduct operations along the most appropriate and direct routes; subject to any applicable rules, regulations or conditions which may be imposed by public entities through which said routes mass.

SECTION I, General Authorizations -- Contd.

Direct Operations: For operating convenience and not as an enlargement of any authority granted herein, The Gray Line Tours Company may, if it deems that it has picked up a sufficient number of passengers in one of the pickup areas provided in Section II of this certificate for one of the tours authorized in Section III herein, proceed directly to the tour from the pickup area without going to its terminal. This authority, however, does not apply to the following:

- a. Item No. 420, Tour 20, from Anaheim-Buena Park Pickup Area to MGM and Universal City Studios.
- b. Item No. 500, Tour 32, from Anaheim-Buena Park Pickup Area to Lion Country Safari.
- c. Items Nos. 430, 440, 445, and 450 (Tours 22, 23, 24, and 25) for passengers originating at Los Angeles International Airport to Disneyland and/or Knott's Berry Farm.

For operating convenience only and not as an enlargement of any authority granted herein, The Gray Line Tours Company may, if it deems that it has picked up a sufficient number of passengers in the pickup areas provided in Section IV of this certificate for one of the tours authorized in Section V herein, proceed directly to the tour without going to its terminal.
