In the Matter of the Application of BALDWIN TRUCKING, INC., a California corporation for authority under Section 3666 of the Public Utilities Application No. 55476 Code of the State of California to (Filed February 3, 1975) deviate from the minimum rates in Minimum Rate Tariff 2 for the transportation of empty aluminum cans and can ends for DEL MONTE CORPORATION. In the Matter of the Application of GUTHMILLER TRUCKING, INC., a California corporation for authority to deviate and depart from the provisions of Minimum Rate Tariff Number 2 in Application No. 55550 connection with transportation of (Filed March 7, 1975) aluminum cans for the account of DEL MONIE CORPORATION, pursuant to the provisions of Section 3666 of the Public Utilities Code. Application of BLACKBURN TRUCK LINES. INC., a California corporation, CONTAINER EXPRESS, INC., a California corporation, and SCHALDACH CONTAINER Application No. 55673 CORPORATION, a California corporation, (Filed May 5, 1975) for authority to deviate from the provisions of Minimum Rate Tariff No. 2 in connection with transportation of empty aluminum cans and can ends.

$\underline{O P I N I O N}$

These applications were consolidated for hearing which was held before Examiner O'Leary at San Francisco on July 2 and 3, 1975. The matters were submitted on the latter date.

Applicants operate as radial highway common and highway contract carriers. Pursuant to the provisions of Section 3666 of the Public Utilities Code they seek authority to assess the rates set forth in Item 640 of Minimum Rate Tariff 2 (MRT 2) for the transportation of aluminum cans for Del Monte Corporation from Stockton to Emeryville and Oakland in lieu of the applicable minimum rates set forth in MRT 2.

Item 640, MRT 2, sets forth commodity rates for the transportation of sheet steel or tin cans and aluminum, steel or tin can ends. MRT 2 does not contain any commodity rates for the transportation of aluminum cans and aluminum cans are therefore transported under the clacs rates set forth in MRT 2.

Evidence presented by applicants discloses that the transportation characteristics of aluminum cans are the same as for the transportation of tin cans. Each applicant with the exception of Container Express Corporation has equipment especially designed to facilitate the loading and unloading of containers such as tin and aluminum cans. Container Express basically operates through the use of subhaulers.

Applicants allege that when practical the shipper utilizes the multiple lot provisions set forth in Item 85 of MRT 2 to consolidate several truckloads of freight into a single shipment for the purpose of meeting the truckload minimum weights applicable to the class rates for the transportation of aluminum cans. Applicants further allege that in many instances the practice of consolidating loads is often incompatible with shipper production and inventory needs.

The California Trucking Association (CTA) urged that the relief sought be granted by amending Item 640 of MRT 2 to include aluminum cans rather than grant the deviation authorities applied for. The position of CTA has some merit however, it cannot be accomplished herein. The amendment of Item 640, MRT 2, should only be considered in a petition for modification or order setting hearing in Case No. 5432 where all interested persons are given an opportunity to present evidence and express their views. Findings

1. The transportation characteristics of aluminum cans for Del Monte Corporation from Stockton to Oskland and Emeryville are similar to the transportation of tin cans for which rates are provided in Item 640 of MRT 2.

2. All applicants except Container Express, Inc. have specialized equipment for the transportation of containers.

3. Applicants' proposal is reasonable and justified.

The Commission concludes that the applications should be granted.

Since conditions under which the service is performed may change at any time, the authority granted in the ensuing order will expire at the end of one year unless sooner canceled, modified, or extended by order of the Commission.

ORDER

IT IS ORDERED that:

1. Baldwin Trucking, Inc., Guthmiller Trucking, Inc., Blackburn Truck Lines, Inc., Container Express, Inc., and Schaldach Container Corporation are authorized to depart from the minimum rates set forth in Minimum Rate Tariff 2 by charging those rates set forth in Appendix A of this decision. This authority does not include any deviation from any rates, rules, or regulations except as specifically set forth in Appendix A.

2. The authority granted shall expire one year after the effective date of this order unless sooner canceled, modified, or extended by order of the Commission.
