ORDER SUSPENDING WAREHOUSE OPERATIVE RIGHT

Gibraltar Warehouses, a corporation, possesses a certificate of public convenience and necessity as a public utility warehouseman for the operation of storage or warehouse floor space at San Francisco and Union City.¹

Applicant states that its public utility warehouse operations in San Francisco were conducted in rented property and it has lost its lease on that property. Applicant alleges that its tenancy expired with March 1, 1975, and it anticipates that a number of months may be required to find suitable space in which to resume operations in San Francisco. Applicant requests authorization to suspend its warehouse operations in San Francisco for a period of one year or until it may find suitable space.

In the circumstances, the Commission finds that suspension of the operative right, as hereafter indicated, would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the warehouse operative right should be suspended for a period of one year.

IT IS ORDERED that:

1. Concurrent with the effective date of the tariff filings required by Ordering Paragraph 2 hereof, the certificate of public convenience and necessity to operate as a public utility warehouseman in San Francisco granted to Gibraltar Warehouses, a corporation, by Decision No. 84404, dated May 6, 1975, in Application No. 55499, is hereby suspended for a period of one year.

2. Within sixty days after the effective date of this order and on not less than five days' notice to the Commission and to the public, applicant shall amend its tariffs presently on file with this Commission to reflect the authority herein granted.

3. Prior to the expiration date of the suspension period or the date service is resumed, tariff filings shall be made to reflect the commencement of service. The required tariff filings shall be made effective on not less than five days' notice to the Commission and to the public and the effective date of the tariff filings shall be concurrent with the expiration date of the suspension period or the date when service is resumed when the latter date is prior to said expiration date.
