SUPPLEMENTAL ORDER

Changes authorized in rates, charges, and conditions for electric service under Appendix B of Decision No. 84902 were found, on further test, to produce \$3,900,000 less than the increased gross revenues authorized of \$150,152,000. In order to correct this error further revision in rates is appropriate.

The Commission finds:

1. The rates authorized by this Commission as set forth in Appendix A attached hereto are fair, just, and reasonable insofar as they produce increases in gross revenues to the various customer classes as shown in Appendix B attached hereto.
2. The increase in rates and charges of \$3,900,000 authorized herein is just and reasonable, and present rates and charges, insofar as they differ therefrom, are for the future unjust and unreasonable.
3. Appendix C attached hereto sets forth a revised bill comparison to conform to the rates adjusted by this decision.



