OPINION

Ray Pilling, an individual, (seller) requests authority to sell and transfer, and Sam Gray, an individual, (purchaser) requests authority to purchase and acquire a certificate of public convenience and necessity authorizing operations as a cement carrier.

The certificate was granted by Decision No. 77850, dated October 20, 1970, in Application No. 52080, and authorizes the transportation of cement from any and all points of origin to and within the County of San Diego. The agreed consideration is \$4,000 payable in cash.

Applicant purchaser presently holds permitted operating authority issued by this Commission. His financial statement filed with the application discloses a net worth of \$196,885.

Applicant seller participates in Western Motor Tariff Bureau, Inc., Agent, Local Freight Tariff No. 17 (Cal.P.U.C. No. 21) which applicant purchaser will be required to adopt or establish as his own in another tariff the same rates and rules effective with consummation of the proposed transfer. Applicants have submitted copies of shipping documents which indicate the certificate has been exercised during the one year period immediately preceeding the filing of the application.

- 3. Purchaser shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the common carrier operations transferred to show that he has adopted or established, as his own, the rates and rules. The tariff filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the transfer. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 117-Series. Failure to comply with the provisions of General Order No. 117-Series may result in a cancellation of the operating authority granted by this decision.
- 4. In the event the transfer authorized in paragraph 1 is completed, effective concurrently with the effective date of the tariff filings required by paragraph 3, a certificate of public convenience and necessity is granted to Sam Gray authorizing him to operate as a cement carrier, as defined in Section 214.1 of the Public Utilities Code, between the points set forth in Appendix A, attached hereto and made a part hereof.
- 5. The certificate of public convenience and necessity granted by Decision No. 77850 is revoked effective concurrently with the effective date of the tariff filings required by paragraph 3.
- 6. Purchaser shall comply with the safety rules administered by the California Highway Patrol and Insurance requirements of the Commission's General Order No. 100-Series.
- 7. Purchaser shall maintain his accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as precribed or adopted

by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of his operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

8. Purchaser shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If purchaser elects not to transport collect on delivery shipments, he shall make the appropriate tariff filings as required by the General Order.

The effective date of this order shall be twenty days after the date hereof.
